### 1. **Announcements**

- 1.1 **Announcements for January 2010** (posted with agenda)
- A. Secco referred Senators to the written announcements, which were posted with the agenda. He welcomed new ALPS Senator Marc André Pelletier.
- S. DeVarenne introduced Joanna Andow, University Records Manager, who has agreed to serve as Acting Associate University Secretary until such time that the appointment of the University Secretary has been made. She will continue to perform her duties as the University Records Manager during this time.

### 2. **Appointment of Senate Secretary**

- A. Secco reminded Senators that a communication was circulated by the President to the University community in late December announcing S. DeVarenne's appointment as Acting University Secretary, until such time as the search for a replacement for Stephen Strople has reached a successful conclusion. He noted that, in accordance with Section 33(8) of the *University of New Brunswick Act*, each Senate must appoint a Secretary, and indicated that S. DeVarenne has agreed to serve while the search for a new University Secretary is underway, subject to Senate's approval.

#### 5. **Question Period**

A. Secco told Senate that he is coordinating a response to Senator Bell's question from the October 2009 meeting of Senate regarding suspension of enrollment in academic programs due to financial constraints. An opinion from the University Solicitor has been obtained and a table of recently suspended programs has been created as part of the response. Further, the topic has been discussed at UMC and at Deans' Council as planned. However discussions were cut short due to time constraints at Deans' Council, and the

A. Secco drew Senators' attention to the questions and responses which were posted with the agenda. He introduced Terry Nikkel, Associate Vice-President Integrated Technology Services (ITS), who was in the room to answer any follow up questions regarding the *UNB Network and Computing Policy*.

Senators Bell, McEvoy, and Wilcox asked for further clarification from T. Nikkel regarding access to files and personal information on ITS servers. In response to questions T. Nikkel assured Senators that the decision to allow access to files and personal information on ITS servers is not made lightly. Under the terms of the *Policy* access is permitted only in limited circumstances and must be authorized by the President or a Vice-President.

In response to further questions, T. Nikkel stated that an individual whose files had been accessed in response to one of the limited situations as described in the *UNB Network* and *Computing Policy* would be notified if the circumstances of the access made such notification appropriate. He added that requests to access files and personal information are rare and are not tracked centrally.

Senator Wilcox asked what physical or technological measures are in place to prevent individuals who have the ability to access files and personal information from doing so at their leisure. T. Nikkel noted that measures such as password protection are in place and that transactions are logged. If an event occurred it could be tracked down. He reminded Senators that such activities and compliance with UNB policy are part of the professional responsibilities of the individuals asked to perform them.

Senator Gail Campbell asked, in follow up to her question on MacLeans faculty-to-student ratio calculations, if she was correct in her understanding that universities with a high proportion of students enrolled in arts or humanities have a scoring advantage over other universities because of the way these disciplines are weighted in the calculations. A. Secco agreed that this was his understanding as well. Senator Campbell also asked if all library holdings, including materials in storage, are included in the McLeans survey calculations. G. Kealey confirmed that all holdings are included.

The Chair asked if there were any questions from the floor.

J. McEvoy asked if the Registrar could supply January enrollment numbers. D. Hinton undertook to provide this information at the next meeting of Senate.

### 6. Activities of the Saint John Senate

A. Secco drew Senate's attention to the activities reports for the 25 November 2009 and 20 January 2010 meetings of the Saint John Senate which were posted with the agenda for information. He noted that the Report of the Undergraduate Scholarship Committee was postponed to the February meeting of Saint John Senate. In addition, the Faculty of Education has indicated its intention to consider proposed revisions to the M.Ed. further and may report back at a future meeting.

## 7. <u>Strategic Planning Process</u>

- 7.1 Strategic Planning Progress Report January 2010 (posted with agenda)
- G. Kealey referred Senators to the January progress report which was posted with the agenda. He reminded Senators that a web-based questionnaire was launched on 13 November 2009 and that the deadline for responding was 14 December 2009. He noted a correction to the report, indicating that approximately 5400 questionnaires were completed. Analysis of these responses is underway and the results will be posted to the website.

Breakout sessions were held in Saint John in mid November and in Fredericton in early December; session co-chairs are working on white papers based on input received at the sessions. The white papers will be posted on the strategic planning website once completed for one further opportunity for feedback from the University community. The co-Chairs will then finalize the papers and provide them to the Strategic Planning Steering Committee for use in preparing the draft Plan.

A sub-Committee of the Steering Committee is meeting with various external groups around the province, including representatives from government, non-governmental organizations, and the business community. More than 15 consultations will take place by the end of March 2010. A summary of input from these meetings will be posted on the strategic planning website once the sessions are completed.

Alex Usher, a higher education professional, spoke to Deans, Directors, Associate Deans, Assistant Directors, Department Chairs, and members of the Steering Committee on 22 January 2010. He focused on global and national developments and trends in higher education. Unfortunately, Usher was not able to give a public presentation due to time constraints. Other experts in the field of post secondary education will be invited to give presentations as part of preparation for strategic planning in the coming weeks; it is intended that there will be an opportunity for the whole University community to participate in an evening session with at least one of the other speakers.

## 8. Report of the Vice-President Finance and Corporate Services on University Finances

- **8.1 2009 Report on University Finances** (posted with agenda)
- D. Murray presented the annual report of the Vice-President Finance and Corporate Services on University Finances. He noted that this is the 20<sup>th</sup> year that his office has presented an annual report to Senate, and that he delivered a similar presentation at Saint John Senate the previous week.

# 8. Report of the Vice-President Finance and Corporate Services on University Finances (cont'd)

**8.1 2009 Report on University Finances** (cont'd)

Drawing Senators' attention to the full report, which was posted with the agenda, D. Murray noted that his four-slide PowerPoint presentation summarizes the report with an overview of the University's financial history, its current financial situation, and what is anticipated in the future.

D. Murray indicated that enrollment at UNB peaked in 2003-04 and that numbers have decreased 15% since that time. Tuition fees comprise approximately 40% of UNB's total revenue, approximately 35% of revenue for the Fredericton campus and approximately 50% of revenue in Saint John. A decrease of 15%, or 12 million, in tuition revenue represents a significant financial challenge for the University. In addition, UNB is has a structural deficit as ongoing revenue continues to be less than ongoing expenses. This was brought to light in the Betts-MacDonald financial review of UNB (July 2006). In response to these two concerns, UNB has exercised tight control over operational expenses.

D. Murray informed Senators that Fall 2009 enrollment at UNBF was below budget targets. Enrollment at UNBSJ was slightly more than budgeted. While this has provided a more stable financial situation in Saint John, the Fredericton campus is facing additional budget challenges.

The total value of deferred maintenance was estimated at \$126 million as at 30 April 2008. The amount of funds contained in the 2008-09 capital budget dedicated for infrastructure renewal was about \$2 million short of what was required to sustain the existing level of deferred maintenance and about \$5 million less than required to begin to make inroads against the backlogs. During the latter part of the 2008-09 fiscal year, the Province announced special stimulus-based capital funding that would be made available to New Brunswick universities for 2009-10 and 2010-11. It is estimated that UNB will receive approximately \$32 million in capital funds which will mainly be deployed against deferred maintenance priorities during this timeframe.

In 2009-10, the operating grant from the Province of New Brunswick decreased by 0.6% compared to funds received in 2008-09. D. Murray noted that budget models were based on a 4% increase in the Provincial grant; this created a considerable challenge for the 2009-10 budget and resulted in a budgeted shortfall of \$3 million. However, the Provincial government has committed to an increase of 3% in the base grant amount for 2010-11 and a 5% increase in lieu of domestic tuition fees. The 5% increase is the same approach taken last year, and represents a \$2.7 million increase to UNB's base operating grant.

Looking ahead, D. Murray indicated that finances will depend on a number of things; enrollment, the economy, the level of the Provincial Grant beyond 2010, expenses, and tuition fees. The Provincial budget did not contain any information on operating grant funding or tuition fees policies beyond 2010. However, the four New Brunswick university presidents will work together going forward to develop a framework which they will present to the Provincial government with the goal of achieving more stable funding for universities in the province.

## 8. Report of the Vice-President Finance and Corporate Services on University Finances (cont'd)

**8.1 2009 Report on University Finances** (cont'd)

D. Murray explained that pro-forma models for the UNBF campus have been developed using the following assumptions: that student enrollment will remain stable as the result of redoubled efforts in recruitment and retention, low inflation, stable markets, a modest increase in provincial grant monies and a modest increase in tuition (which may come from a tuition increase or continued provincial funding).

In response to a question regarding UNB's trust and endowment accounts, D. Murray noted that the University's investments have begun to recover from the sudden sharp decline experienced early in 2009. In February 2009, the total value of trust and endowment accounts reached a low of \$135 million, at 31 December 2009 this had recovered to approximately \$169 million. The overall market value has not yet returned to its March 2008 high of \$174 million.

E. Maher requested an explanation of the variance in deferred contribution amounts between the current year and the previous year. L. Guitard explained that New Brunswick Universities received the Provincial grant on an accelerated basis for the past two years. The Province returned to the normal operating grant cash distribution schedules for 2009-10. This difference in timing is reflected in the deferred contribution line.

E. Maher noted that the results for the year included an unfavorable variance from budgeted bad debt expense in the amount of \$324 thousand. She asked what the total bad debt expense was for the year. L. Guitard responded that the actual bad debt expense for the year was \$344 thousand compared to the budget provision for bad debt expense of \$20 thousand. He indicated that the total bad debt expense includes allowances for uncollectable accounts within various categories of receivables including general receivables, student receivables, and research receivables. (L. Guitard agreed to provide a further breakdown of bad debt expense for 2008-09 by category.)

<u>Secretary's Note:</u> L. Guitard provided the following breakdown of bad debt expenses:

S. Lord asked if there would be additional fees for students, such as a Currie Center fee. D. Murray replied that some universities have chosen to have fees for similar facilities. There are no plans to implement such a fee in the coming year while the building is still under construction. However, it is an option that may be considered as part of the operating plan for the Currie Center once it is put into service.

# 8. Report of the Vice-President Finance and Corporate Services on University Finances (cont'd)

**8.1 2009 Report on University Finances** (cont'd)

M. Couturier asked about government funding for infrastructure renewal. D. Murray indicated that \$16 million was received from the Knowledge Infrastructure Program (KIP); this money will be divided equally between the Currie Center and University Commons projects. \$15 million was received from the Provincial government last year, with \$7.5 million expected this year and next year. M. Couturier asked what this funding will mean in terms of reducing deferred maintenance. D. Murray explained that each year UNB must spend \$4-5 million to keep the level of deferred maintenance steady. Government funding will mean a net decrease, but the reduction to deferred maintenance will be less than \$30 million.

## 9. Report of the Senate Admissions Committee

**9.1 January 2010 Report** (posted with agenda)

This matter was referred back to the Committee for further consideration at the October 2009 meeting of Saint John Senate. The Committee has reconsidered the matter and has proposed that 2009 be the only year where 2 medals are awarded. Going forward, the Education medal will be awarded at Fall Convocation.

# 15. <u>Motion to Amend Composition of Faculty Councils in the *University of New Brunswick Act* (posted with agenda)</u>

G. Kealey reminded Senators that, at the November 2009 meeting of Senate, the President noted his intention to bring forward a proposal to amend the membership of Faculty Councils as provided for in Section 34 of the *University of New Brunswick Act*. He explained that, at present, the membership of most Faculty Councils is limited to the President, the relevant campus Vice-President, the Dean, heads of departments, faculty members, and students where provision has been made by the Faculty Council to allow for student membership. The exception to this is the Faculty of Law, which has flexibility to include 'such other members as the Faculty of Law shall determine.' The proposed amendment to the *Act* will offer that same flexibility to UNB's other Faculties. This recommendation will allow Faculties to include as members of Faculty Council as they shall determine such people as part-time instructors, adjunct professors, honorary research associates, and post-doctoral fellows in consideration of the involvement such appointments have in the academic work of the Faculty.

He further proposed that Faculty Councils and Library Boards on each campus consider the establishment of regulations for additional membership and participation in Council and report back to Senate on such regulations by May 2010.

G. Kealey reminded Senators that pending the amendment of the *University of New Brunswick Act*, membership and participation of such members on Faculty Councils would not be voting, except in the Faculty of Law. However, subject to sections 47 and 48 of the *UNB Act*, membership on Faculty Council committees may be voting as determined by the particular Faculty Council.

#### MOTION 15,1

G. Kealey/Townsend "That Senate recommend to the Board an amendment to section 34(2) of the *University of New Brunswick Act* as follows:

34(2) Each Faculty Council on the Fredericton campus, subject to the provisions of this Act, shall consist of the President, the Vice-President (Academic), the Dean of the Faculty, the heads chairs of the departments and the faculty members, except that for the Faculty of Law the Faculty Council shall consist of the President, the Vice-President (Academic), the Dean, the faculty members and such other members as the Faculty of Law each Faculty Council shall determine;

and that Faculty Councils and the Library Board on the Fredericton campus consider the establishment of regulations for additional membership and participation in Council and report back to Senate on such regulations by May 2010."

## 15. <u>Motion to Amend Composition of Faculty Councils in the University of New Brunswick Act</u> (cont'd)

- S. Carmont-McKinley, Undergraduate Student Senator, noted that student representation on Faculty Councils is not consistent across the University. She proposed that the Motion be amended to provide for student representation. S. DeVarenne noted that provision for student representation on Faculty Councils is provided in Section 74 of the *UNB Act*. She invited S. Carmont-McKinley to meet with her to further discuss the issue of student representation on Faculty Councils.
- D. Bell suggested that the Motion represents a landmark in that it recognizes participation of part-time instructors in the academic life of the University. He further stated that Faculty Councils should be encouraged to include such members. D. Bell also requested it be noted in the Minutes that the expansion of Faculty Council membership is meant to pertain to those involved in the academic work of the Faculties.
