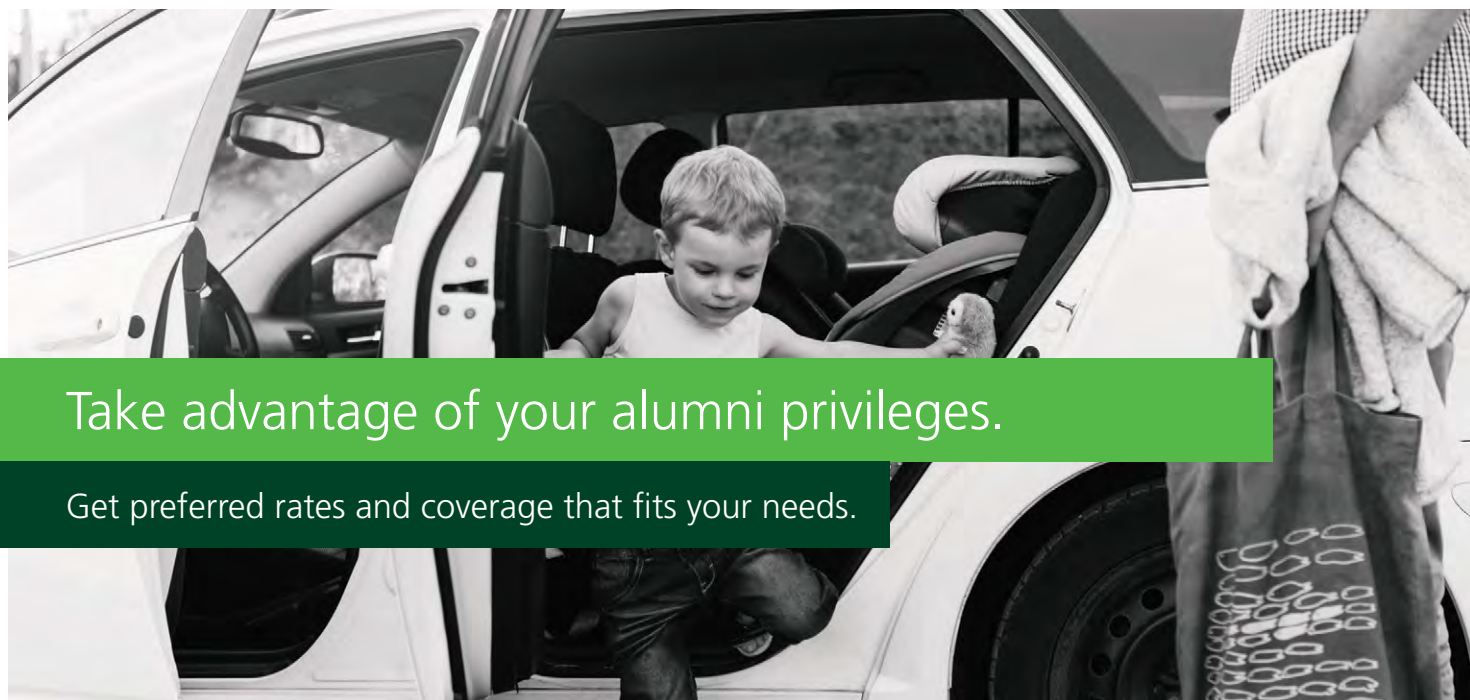

NEW KINESIOLOGY BUILDING

The new kinesiology building is a project that's been on UNB's priority list for more than a decade, and thanks to funding from the federal and provincial governments, the project is currently underway on UNB's Fredericton campus.

The 60,000-square-foot, \$36-million building will create a nationally significant research cluster focused on health, wellness, physical fitness and health promotion, which will strengthen New Brunswick's role as a leader in preventative health care. It will be adjacent to the

west side of The Richard J. CURRIE CENTER, with a connection that will provide a direct link to the Andrew and Marjorie McCain Human Performance Lab.

The expected completion date is spring 2018. A number of initiatives are underway to celebrate the new home for the faculty of kinesiology and to commemorate the Lady Beaverbrook Gym, which will be decommissioned in the fall of 2018. A couple of these initiatives include reusing wood from the Lady Beaverbrook Gym in the new building and placing a time capsule in the building's cornerstone. 🌱

NEW CENTRE FOR CHILDREN WITH COMPLEX HEALTH CONDITIONS LAUNCHED

Researchers at UNB and Mount Allison University have teamed up to launch a new centre dedicated to helping children, like Cameron Fiander, with complex health conditions. NaviCare/SoinsNavi is a virtual centre that will help young patients and their families navigate the maze of health care needs and professionals they often confront.

Funded by a \$750,000 donation by the New Brunswick Children's Foundation, the 24-hour, seven-day-a-week service was developed by UNB's Shelley Doucet (BN'05, PhD'10), holder of the Jarislowsky Chair in Interprofessional Patient-Centred Care, and Mount Allison's Rima Azar.

"The navigation centre has the potential to significantly improve health care for children with complex health conditions in New Brunswick by ensuring that they have access to integrated collaborative care that is timely, convenient and meets their unique needs," says Doucet.

"Our vision is that every child or youth with a complex health condition receives the care they require in a timely manner, in the appropriate setting for his or her family," says Azar.

A unique aspect of NaviCare/SoinsNavi is the involvement of a patient navigator, which is a relatively new and innovative role in Canada. The navigator advocates for children and their families while being a resource for the care team.



CANADIAN INSTITUTE FOR CYBERSECURITY OPENS

The Canadian Institute for Cybersecurity (CIC), an innovative hub for research, training and industry collaboration, opened at UNB in January. The institute will train highly skilled cybersecurity professionals and provide leading-edge research into one of the most pressing issues facing society today.

IBM is CIC's first research and development partner, helping to fund resources in the field of cybersecurity and other in-kind contributions, such as technical and management resources to provide project oversight and mentorship for students.

CIC, housed at existing facilities on UNB's Fredericton campus, will operate in close collaboration with researchers in the social sciences, business, computer science, engineering, law, and science, as well as other national and international research centres. Ali Ghorbani (PhD'96), dean of computer science and Canada Research Chair in cybersecurity at UNB, serves as the institute's director.

UNB has played an important role in the success of cybersecurity research and innovation in New Brunswick. Today, UNB's faculty of computer science has the largest network security research group in the nation and is poised to seize the opportunity to lead this effort through the Canadian Institute for Cybersecurity.

For 150 years, *The Brunswickan* has been a vehicle for advocacy, news and information, and entertainment for students. While its look and content have changed over the years, *The Brunswickan* has always stayed true to its goal of covering issues that are important to UNB Fredericton students.

Here's a look back at the evolution of Canada's oldest university publication.

150 Years and Counting

The University Monthly declared it would not only be a place for literary discussion, but it would also be an agent of change, helping to reform the academic system and to improve the college library, among other various projects.

1867 · First issue of *The University Monthly* (aka *The Monthly*) was published. It presented itself as a journal devoted to literature, science and general information. With limited readership, and after only a few issues, the paper folded and remained dormant until 1882.

1882 · *The University Monthly* was revived and without recognizing the earlier editions, was published as Vol. 1, Issue 1. It was available on the last Thursday of each month and a subscription was 50 cents per term.

1883 · Regular sports coverage started.

1885 · First issue with artwork was published (March issue). It contained hand-drawn illustrations of Indian etchings of Passamaquoddy Bay.

1890 · After another hiatus, a special edition was published and featured photographs of the Fredericton campus and the surrounding area.

1922 · A change in student government and in the constitution of university publications led to a redesign and renaming of *The University Monthly* to *The Brunswickan*. A contest was held for the new name and format.

1931 · *The Brunswickan* became a weekly publication.

1939 · Female students took over the production of *The Brunswickan* for co-ed week, producing the first co-ed edition of the paper.

1984 · A sports photo was featured for the first time on the front page.

1986 · *The Brunswickan Alumni Club* was formed. Since 1910, more than 1,000 students have served on the publication.

2009 · *The Brunswickan* switched from a broadsheet to a tabloid.

HOW UNB CAN BE A CATALYST FOR TRANSFORMING NEW BRUNSWICK'S ECONOMY

For New Brunswick, as a small 'have less' province in Confederation, the challenges of industrialization and economic growth have never been greater. Economic forces under globalization have resulted in competitive advantages for jurisdictions with larger populations and capital stocks associated with large firms. These advantages are prominent in new and emerging knowledge-based industries where firms tend to cluster in a given location. From this perspective, for New Brunswick, strategic investment in university research, technology transfer and education is an opportunity to offset the locational disadvantages of a small economy and potentially seeding industrial clusters.

Universities as critical knowledge infrastructure for regional development, suggest that we need a new mindset for regional development. Traditional approaches, particularly in Atlantic Canada, focus on encouraging firms to start up and locate in the region. Universities are typically seen as supporting regional development and as adding value to the economy with its graduates and through the multiplier effects on GDP from university expenditures. In this light, universities are encouraged to align their education programs to meet projected skills needs.

The traditional approach to regional development is devoid of any innovative thinking about how to do regional development and of understanding of the leadership role a university can play in regional development.

At UNB there are several prominent initiatives that highlight a new approach for regional development through an engaged university model.

The New Brunswick Institute for Research, Data and Training (NB-IRDT) on UNB's Fredericton campus, for example, is a foundational initiative that addresses the obstacles to smart government.

Through NB-IRDT's development of data infrastructure, government can take full advantage of the information on citizens and programs that it routinely collects, the expertise in the research community to analyze it and the computational power of the era of big data. By providing a holistic picture of the well-being of New Brunswickers and the opportunities to guide continuous improvement in the business of government, the leadership of UNB has the capacity to transform government. New Brunswick already collects a lot of information on its residents, now it needs to accelerate the pace at which it is harnessing and utilizing that data for the benefit of all its citizens. Mining that lode of data will create jobs and spur financial innovation in areas such as social impact investing. By allowing government to spend better, making tax dollars purchase more for citizens, the fiscal challenges of New Brunswick with an aging population will be reduced.

Emera and NB Power have partnered with UNB to establish the Emera & NB Power Research Centre for Smart Grid Technologies. This centre, which received a \$6.2-million investment from Emera in 2017, will

fuel innovation and growth in the Atlantic Canadian economy and secure UNB's position as an international leader in smart grid research and commercialization. But this initiative is not about UNB developing products. It is about applying and developing emerging technologies and products to address fiscal and energy challenges in the Atlantic region. The products and technologies that are associated with smart grid, like electric vehicles and batteries, exist in some form and they will have a market somewhere as standalone products whether smart grid is realized or not.

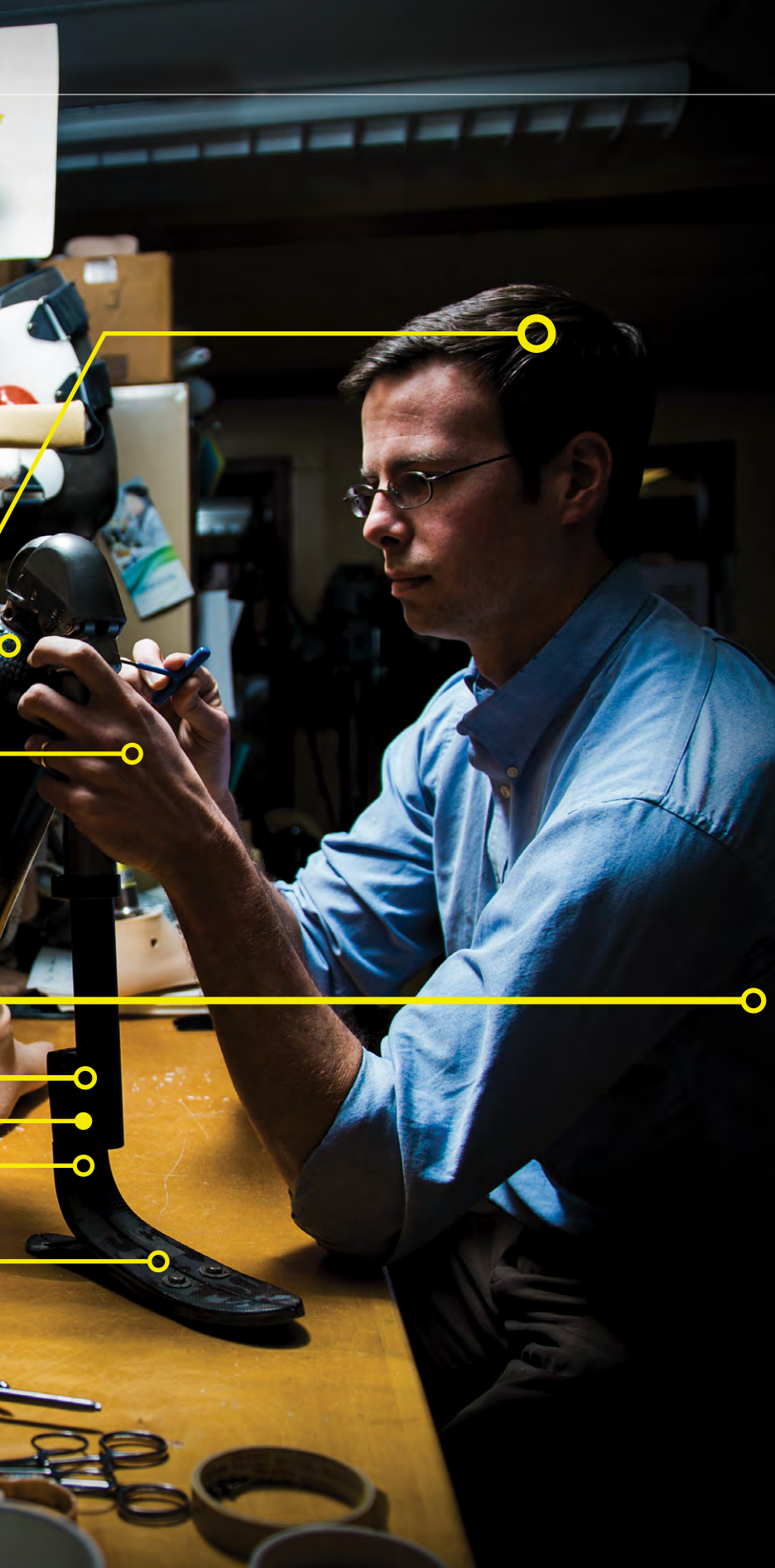
The value of smart grid comes from innovative activity to apply largely existing technologies to add value to the large and important energy sector of the economy. New Brunswick will benefit from lower and predictable energy costs, reduced carbon emissions and likely, energy exports.

Engaged universities find solutions to societal challenges. Finding these solutions will make New Brunswick a better place to do business, which in turn will attract the investment that stimulates economic activity.

== JON SENSINGER TURNS CHILDHOOD
DREAM INTO REALITY



For Jon Sensinger, associate director of UNB's Institute of Biomedical Engineering, a childhood dream has turned into an innovative career - one that is changing lives.

"I'm always telling people that I love every aspect of my job," says Sensinger. "Whether it's helping other staff in a managerial sense or teaching students and learning myself through the process, or whether it's interacting with patients or designing things.

"I think my only regret is that all those activities are so much fun and it's hard to fit them all in."

A pioneer in the field of biomedical engineering, Sensinger was named 2016 Young Health Researcher of the Year by the New Brunswick Health Research Foundation.

His research focuses on understanding how the human brain can work in tandem with the control interfaces created to operate a prosthesis - in other words, finding ways to develop thought-controlled bionic limbs.

"You know the media is always talking about how good prostheses are and relative to airplanes and cars it is phenomenal technology, but relative to the human body we still have such a long way to go and so part of me looks at the gap or the need there and is motivated by that," he says.

While children and adults often explore many career paths before finding their calling, Sensinger knew at three years old that he was meant to innovate, design and build. »

» In elementary school, seeing friends and classmates struggle with physical disabilities, he was inspired to find a way to help. While working on a career project in seventh grade, his teacher told him about the field of prosthetics. With encouragement from engineers at a local prosthesis shop, he began to pursue a bachelor's degree in biomedical engineering, and then a PhD.

He knew that he wanted to do research in prosthetics, but struggled to find a dean who would consider allowing a first-year student to take on his own research. At the University of Illinois in Chicago, after it seemed like another door had closed, an administrative assistant told him about a professor who might be willing to take him on. That professor was Farid Amirouche and he mentored Sensinger throughout his undergraduate degree, providing him with a strong foundation of research experience.



“So, I did my undergrad, master's and PhD in biomedical engineering and was exposed to UNB during that time because UNB is probably one of the three to four world leaders in prosthetics - and has been since its inception.”

“The whole international community convenes here at UNB every three years and so I, along with everyone else, came here around 2005. I was really impressed by the research that was done here, and also impressed by the researchers themselves who were, you know, world-renowned researchers, and also really personable and friendly.”

After earning his PhD, Sensinger worked as a professor in Thailand and was director of the Prosthesis Design and Control Laboratory at the Rehabilitation Institute of Chicago before being recruited by Kevin Englehart (BScEng'89, MScEng'92, PhD'99), director of UNB's Institute of Biomedical Engineering.

“Jon has been a tremendous presence at the Institute of Biomedical Engineering here at UNB since arriving in the fall of 2013,” says Englehart. “The standards he sets in terms of the quality of his work has been an inspiration to his students and colleagues. He collaborates easily with colleagues at UNB and around the world, which has broadened the scope of activities at our institute leading to research in exciting new directions.”

A music enthusiast and outdoorsman, Sensinger plays the cello for his church and is a leader with Scouts Canada. In his spare time, he enjoys both playing and building instruments. His approach to instrument making is akin to that of engineering, “I like to be guided by a set of principles or equations, but I also like to be guided by experiments.”

When asked about the best part of his job, Sensinger says, “I really think it's a combined package and I think that's true for biomedical engineering in general. It tends to be a jack of all trades field where you've got to not necessarily have expertise in any one area, but you need to know a variety of areas” - a philosophy that seems to apply to all areas of his life. 🍌

THE PAST

One hundred years ago, during the spring of 1917, Canadian soldiers were given the order to seize Vimy Ridge and drive out German forces entrenched there almost continuously since the beginning of the First World War. On April 9, the soldiers stormed the ridge, and on April 12, liberated their French allies - 3,598 Canadians were killed and about 7,000 were injured.

Among those who fought at Vimy Ridge were Major John 'Jack' Hales Sweet (BA 1899) and Bombardier John I. Morrison (BScEng 1914).

Major Jack Sweet was born in Dalhousie, NB, in 1878, and attended high school in Miramichi, NB. He graduated from UNB in 1899 with a bachelor of arts degree. While at UNB, he was editor of *The University Monthly* (which later became known as *The Brunswickan*).

In 1915, Sweet volunteered his services to the Canadian Corps and obtained a commission as lieutenant in the 72nd (Seaforth Highlanders) Battalion at the northern end of Vimy Ridge, facing the community of Givenchy-en-Gohelle, France. He was later promoted to a captaincy and then to the position of Major.

Shortly after the main assault opened on Vimy Ridge on April 9, Sweet was wounded in the arm. He refused to go for treatment and continued the assault towards Givenchy-en-Gohelle. He and his company won control of the first German trench where Sweet was hit by shrapnel and killed. His remains lie in the military cemetery at Villers au Bois, marked by a cross, only three miles from Vimy Ridge.

Bombardier John Morrison was born in Saint John, NB, in 1893. He received his early education in the public schools of Saint John and entered UNB in 1910. He had an enviable scholastic record and was a very prominent athlete.

Soon after graduating from UNB in 1914, Morrison volunteered with the 23rd Field Artillery Battery, which was made up of students and graduates from Maritime universities.

The Maritime student gunners arrived in France in early 1915. At Vimy, Morrison served as a signaler in the 2nd Field Artillery Brigade, positioned on the southern end of Vimy Ridge. Morrison survived the battle at Vimy, only to be fatally wounded at Passchendaele later that year. He died at the Canadian Hospital at Etaples in December 1917.



THE PRESENT

For many Canadians, the Battle of Vimy Ridge is a defining moment in the country's history, and for the people of France, they will always remember the Canadian soldiers who helped to liberate parts of their country.

“Nowhere was the connection between Canadian troops and the French people deeper than at Vimy Ridge,” says Lee Windsor, deputy director at UNB's Gregg Centre for the Study of War and Society. “In particular, the shell-battered Givenchy-en-Gohelle, at the foot of Vimy Ridge, is one of the villages Canadians came to know well after the Germans abandoned it in April 1917.”

To mark the centennial of the Battle of Vimy Ridge and to commemorate the special relationship between Canada and France, the mayor of Givenchy-en-Gohelle declared 2017 the Year of Canada in his village. Throughout 2017, Givenchy is hosting celebrations and ceremonies, and every house and business in the community is proudly displaying a Canadian flag - thanks to UNB's Gregg Centre for the Study of War and Society and Kent Building Supplies who gifted Givenchy with the flags.

“The Flags for Vimy project serves as a reminder to all of us of the special relationship that exists between France and Canada, one that has profoundly deepened through two destructive world wars, and one that remains strong to this day,” says Gregg Centre director Marc Milner. “One New Brunswick infantry battalion played a central role in the assault on Vimy Ridge. Within it were UNB alumni, so it's fitting that once again New Brunswick, and UNB, are lending a hand to Givenchy-en-Gohelle. This time for a happy occasion.” 🇨🇦

1 Catherine Sutherland (BA'78, BBA'94)

Catherine Sutherland is a devoted and longtime supporter of UNB. She served as a member of the Associated Alumnae Council for several years, most notably as Alumnae president from 2006-08. During her term as president, Sutherland played a fundamental role advocating for UNB during tumultuous times for the Saint John campus and the women's varsity hockey team.

A regular volunteer in the community and with the Alumnae and Alumni associations, Sutherland is passionate in her efforts to engage

alumni. A regular attendee at alumni celebrations, Sutherland is fiercely proud of her *alma mater* and is an outstanding ambassador for UNB.

a person-centered care model, into the centre and province.

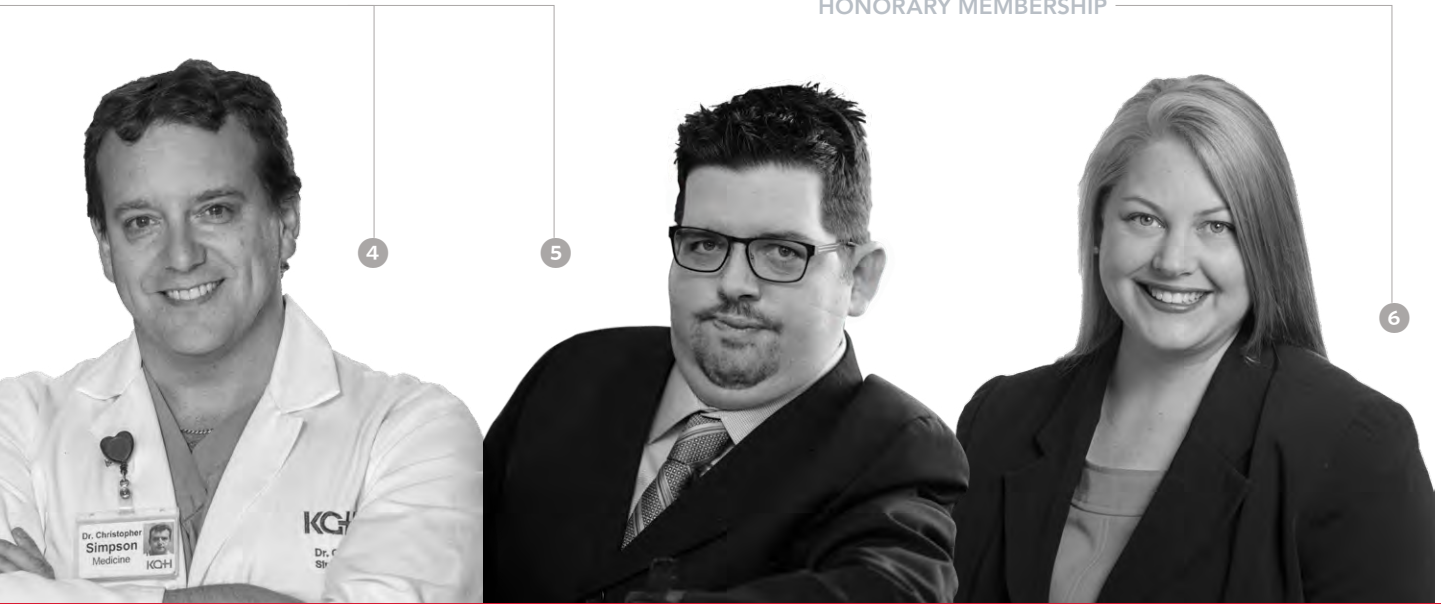

3 Ann Gushurst (LLB'94)

Ann Gushurst is a shareholder and president of the Colorado family law firm of Gutterman Griffiths PC and is a leader in family law litigation, mediation and collaborative law.

4 Dr. Christopher Simpson (BSc'90)

Chris Simpson is vice-dean (clinical) of the School of Medicine at Queen's University, medical director of the Southeastern Ontario Academic Medical Organization and former president of the Canadian Medical Association. A national and international leader in cardiology, Simpson was instrumental in championing seniors' care and helping guide the profession on issues of medical aid in dying and medical marijuana.

Widely recognized in his field, Simpson has authored or co-authored over 350 peer reviewed papers and is an active clinician, educator and researcher.

5 Jeffrey Sparks (BBA'96)

Jeff Sparks is the national director of volunteer engagement and organizational development with Muscular Dystrophy Canada. He has made significant efforts to raise funds for the organization and to increase awareness of neuromuscular disorders.

Well known in his community as a passionate volunteer and an advocate for people living with disabilities, Sparks is past-president of the Saint John Ability Advisory Committee. In this role, Sparks implemented an accessible sidewalk policy and enhanced the para-transit system. Sparks has received the YMCA Leader to Watch, 21 Leaders for the 21st Century and the Terry Fox Humanitarian Awards for his outstanding contributions.

Recognizes many years of valuable contributions to the UNB Associated Alumni or the University of New Brunswick.

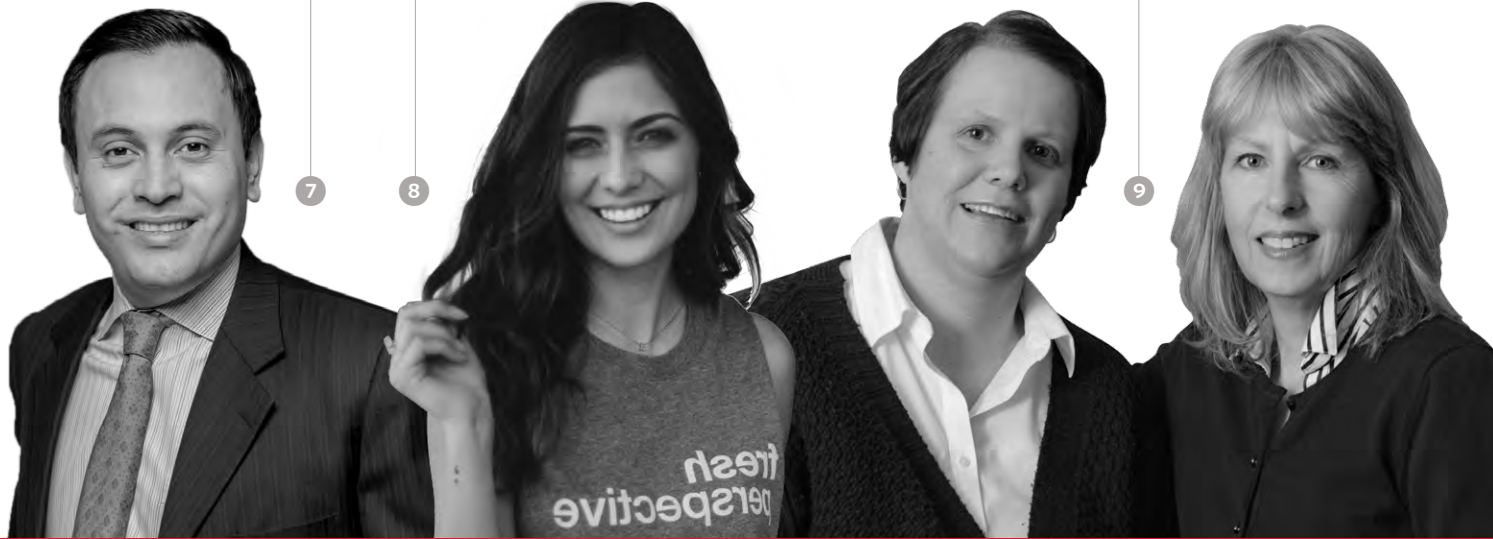
6 Jennifer Waldschütz

SCOTT SMITH TO HEAD UP HOCKEY CANADA

ALUMNUS HOPES TO MAKE THE
SPORT ACCESSIBLE TO EVERYONE

Passion, grit and determination are words that are often used to describe Canada's athletes. They are also the principles that have shaped Scott Smith's career. A UNB alumnus and New Brunswick native, Smith (BE'd'88) will help lead the sport of hockey as the newly appointed president of Hockey Canada, effective July 1.

Bringing a wealth of experience to the position, Smith will deliver on Hockey Canada's mandate of attracting more youth to participate in the sport of hockey in Canada, while working to maintain a very strong position on the international stage in world championship events. Honoured to take on the president's role, he says he will work alongside members of the organization's executive leadership team, including CEO Tom Renney who announced Smith's appointment this past December.

"With Scott's leadership, strengths and passion for the game, he will maintain our vision of making hockey accessible for everyone, as well as growing our game and being a champion of all our national teams," says Renney.

Since joining the Hockey Canada team in 1995 as manager of hockey operations for its Atlantic Centre of Excellence in Saint John, Smith has held a number of responsibilities including director of operations and vice-president of operations at the Calgary office. In 2007, he was named chief operating officer and will continue running the overall business and daily operations of the organization as president.

"We're recognizing that the demographics in Canada are changing and there is not the same predisposition to register a five year old boy or girl to play hockey as there was maybe 25 years ago," says Smith. "We're looking at an alternative approach to the regular hockey season as a first-staged entry and are doing everything we can to eliminate some of either the real or perceived barriers of the participation to sport in general, but also specifically to hockey."

A graduate of UNB's bachelor of education program, Smith came from a family of educators and says he felt education would allow him to be involved in hockey on a voluntary basis, a sport he's been passionate

about since a young age. Little did he know that the education program would also spark his passion for the business of sport working with mentors such as Bill MacGillivray who was UNB's dean of physical education and chairman of the board of Hockey Canada at the time.

"My UNB education prepared me for many things in a personal and professional setting, and I think when I first started it gave me a real thirst for continuing to learn," says Smith.

Not long after graduating from UNB, Smith was hired by Hockey New Brunswick as its first full-time technical director, and his passion for the sport has only grown stronger. Outside his professional career, he coaches his son Jackson's hockey team and helps manage a full-size rink for his community.

"I've been fortunate to meet a number of great people, whether they're administrators, leaders, coaches or athletes who have significant talents and drive," says Smith. "Being and working in an environment where there is constant drive for success is something I truly enjoy."

For **Kelsey Bond**, a first-year kinesiology student, the dream of combining sport and education at UNB began in her hometown of Bridgewater, NS. As one of the top volleyball players in her province, she was interested in a career in kinesiology. She knew that UNB, with its reputation for excellence in university sport and in her academic field, would be the perfect fit for her aspirations. Her motivation and commitment paid off when she was accepted into UNB and then when she earned a berth on the Varsity Reds volleyball team. Alumni support for renewable scholarships, such as the Sharpe Family Scholarship created by Dawn (BScEng'64, DSc'10) and Susan Sharpe, was also critically important to Bond achieving her dream, as she was raised in a single parent home with two sisters. Thanks to the generosity of UNB alumni, she can meet the demands of the classroom, while maintaining the dedication required to perform on the women's volleyball team.

For **Ethan Augustine**, a second-year biology major, it began in the Metepenagiag First Nation. Augustine was inspired by the leadership of his cousin, Chief Noah Augustine, who is an advocate for youth, stressing to them the importance of education. Armed with that advice and supported by his parents and other family members, Augustine became a dedicated student who made great academic achievements, eventually earning a Lord Beaverbrook Scholarship at UNB. Extracurricular activities, such as his leadership roles at Harrison House residence, have played an important part in Augustine's development, broadening his university experience and affirming his skills outside the classroom. He has set his sights on graduating with a science degree and becoming a leader who can inspire the next generation of youth in his community.

For **Luke Duffley**, a fourth-year science student, it began shortly after his graduation from Rothesay High School, when he began taking on community projects that allowed him to make a difference in the lives of others. His involvement included duty with Saint John Ambulance, volunteering at the Saint John Regional Hospital, participating with groups on campus, and helping to bring a Syrian refugee student to UNB Saint John through the World University Service of Canada. Duffley has gained important leadership experience through these activities and has achieved high academic performance. He sees earning his bachelor of science degree as the first step to a possible career as a physician. Scholarships, including awards funded through generous alumni bequests such as the Rhoda and Ronald Woodworth Scholarship, have played a large role in allowing Duffley to build strong personal, professional, community and academic foundations. »

Eaton Chair in Canadian Army Studies, a prestigious position created through a \$1-million gift from alumnus and former chancellor Fredrik Eaton (BA'62, LLD'83). Prepare Our Students to Succeed in the World

For **Nicole Maxwell**, third-year arts student, her internship at the Fredericton Region Museum began with the support of philanthropist and former UNB Board of Governors member Nancy McFadyen (BA'67, DLitt'06). Believing that all students should have opportunities to learn outside the classroom, McFadyen has pledged support to expand UNB's faculty of arts internship program, which places up to 30 undergraduate students per year in unpaid, for-credit internships with local non-profit organizations and community partners, including the Beaverbrook Art Gallery, the New Brunswick Filmmakers Cooperative and the New Brunswick Sports Hall of Fame.

For **Alison Luke**, it began with the desire to make health care more responsive to patient needs. ing the face of equine reproduction

LISA PFISTER'S NEW TECHNOLOGY WILL HELP TO MORE ACCURATELY PREDICT BIRTHING IN MARES

Lisa Pfister (BScEng'16, MTME'17) has created a technology that has the potential to forever change the equine breeding industry.

Pfister, a graduate of UNB's technology management and entrepreneurship (TME) program, grew up around horses, watching her mother ride, but never took an interest in them herself. It wasn't until age 12 when she rode for the first time that everything changed.

"As soon as I got on the horse, I thought okay, this is pretty cool, I think I'll do it."

When the mare she had been riding began to near the end of its sport horse career, Pfister became

interested in the idea of breeding. By 2014, her mares had their first set of foals. To learn more, she decided to take a job as a summer breeding intern on Prince Edward Island.

"It was a bit different considering I was doing civil engineering the other eight months of the year," she says.

She learned that mares usually gestate between 320 and 370 days, making foal watch an important part of the job. One of the ways to estimate a due date is through testing the pregnant mares milk. Typically, this is done using test strips and then comparing them to a colour chart - much like in a chemistry class.

"It is scientifically proven that you've got certain chemistry levels in the

milk that go up or down depending on how close they are to giving birth and that's how you predict when it will actually happen," says Pfister. Another method is to sew a device into the horse that triggers an alarm when they begin to give birth. Pfister tried this method, but when the mare began giving birth the alarm did not go off and the foal was upside down. If she hadn't been on site, both the mare and the foal could have died. After that experience she thought, "there must be a better way."

It was her engineering mind that inspired her to keep a record of milk tests and birth dates and she began to notice trends in the data. With that information, she was able to create an algorithm that led to the inception of PFERA Inc. »



In March, Lisa took home \$375,000 in cash and professional services – the top provincial prize – at the New Brunswick Innovation Foundation's Breakthru Competition. She is also the inaugural recipient of the Sholtbolt Award, funded by Kelly (BBA'79) and Mary Lou (BPE'80) Shotbolt.

» The animal-health biotechnology automates and significantly increases the robustness of the milk testing process. Once a sample has been obtained, it is inserted into the device, which tests certain ion concentrations and chemistry levels. The results are then sent to the user's smartphone, eliminating human error as there is no need to interpret the test strip.

"The additional advantage of the system is the statistical analysis and trend monitoring of the results, which further enhance the accuracy

through the implantation of an adaptive algorithm," says Pfister. "The algorithm enables customized predictions based on the mare's unique signature."

This non-invasive system keeps the welfare of the horse its top priority. Thanks to her algorithm, Pfister's technology can predict birth date and time down to six to 12 hours, which surpasses the range and reliability of any of the industry's competitor's products.

While nearing the end of her bachelor of civil engineering degree at UNB, a friend suggested that she look into the TME graduate program. She knew she wanted to start her own business, so the program seemed like a great fit.

"It's been, if anything, like a launchpad," says Pfister. "TME has been a great help to me, with its network and resources that are available to the students of the program as a part of the curriculum. Whether it's information about intellectual property advice or general business advice, there is always someone willing to listen and help."

In February, supported by TME, Pfister presented her research at a conference in Grantham, England. She received very positive and encouraging feedback from the equine community and raised significant interest in her work. Her poster, presented at the conference won the award for best student research poster.

"I thought wow, I don't think I ever would have gotten this opportunity without the help and guidance of UNB and TME," she says.

With her patent pending, the future is bright for PFERA Inc. In April, she will launch a pilot project on Prince Edward Island with three different farms and a veterinarian using her software. Pfister has had requests and interest from breeders around the world and in 2018, she will be able to release the software and milk analysis system to the public.

When asked how her work might change the field of equine reproduction, "Oh the field? I'm planning on completely disrupting it," she says with a smile. 🐾

TRAVEL INDUSTRY INNOVATORS SUPPORT STUDENT ENTREPRENEURS

THE MERIT TRAVEL FUND WILL ALLOW STUDENTS TO CONNECT WITH NATIONAL AND INTERNATIONAL MENTORS

The entrepreneurial couple behind Canada's largest independent specialty travel business, Merit Travel Group, has made a quarter-of-a-million dollar commitment to help student entrepreneurs at UNB. The \$250,000 Merit Travel Fund will support students enrolled in UNB's Technology Management & Entrepreneurship (TME) programs, by supplying travel for experiential learning opportunities.

Merit Travel Group co-owners and co-founders Michael Merrithew (BBA'80) and Louise de Grandpré (BPE'79, BBA'80) met at UNB's Fredericton campus. They created Merit Travel in 1991, inspired by an entrepreneurial plan that Michael devised as part of a class project at UNB. Since then, they have grown the company's operations to 420 agents nationwide, serving more than 350,000 travellers each year.

The two have been engaged alumni of UNB, funding prizes and bursaries and serving as judges for UNB student business pitch competitions. Merrithew says this initiative will bring Merit Travel's capabilities to UNB's young entrepreneurs, giving them the best start in business. The fund will provide opportunities for students to attend pitch competitions, pursue investment opportunities, and meet and be mentored by national and international entrepreneurs and leaders in business. "We have a strong interest in fostering the growth of entrepreneurs," says Merrithew.

"When you're a business owner, a lot depends on your mindset and your ability to accurately assess risks and opportunities. Because those decisions are almost

never obvious or easy, we want to give students the opportunity to connect with world-class mentors, seek out knowledgeable investors and pitch their ideas. The Merit Travel Fund will help them do that."

De Grandpré says the couple was impressed by Dharendra Shukla, chair of UNB's J. Herbert Smith Centre for Technology Management & Entrepreneurship, and UNB's TME program during their recent visit to campus.

"The enthusiasm of Dr. Shukla and his team is contagious, and with all the successful student businesses that have come out of the TME program, we can see why," says de Grandpré. "We had been out of university for a decade when we founded Merit Travel. Through TME, student entrepreneurs at UNB are creating innovative and competitive businesses today."

Shukla credits supportive alumni like Merrithew and de Grandpré with the J. Herbert Smith Centre's success. "This is an example of how UNB has earned its reputation as Canada's most entrepreneurial university," he says. "Our students have won the support of some of the greatest business people in Canada. We are very happy to be working with Michael and Louise on this initiative." 🌱

STEWART MCKELVEY COMMITS \$200,000 TO SCHOLARSHIPS FOR UNB LAW STUDENTS

Niko Valsamis (JD'17) has a wide-ranging résumé. The new law alumnus dabbled in martial arts before coming to UNB, winning a World Kickboxing Association's amateur Muay Thai middle weight title in New York. He also worked as a junior therapist for children with autism spectrum disorder.

While he found both of these experiences fulfilling, Valsamis has another passion. "I have been drawn to litigation ever since I started competing in undergraduate mooted competitions," says the co-founder of the UNB Law Mooting Society. "Advocacy is intellectually challenging and allows me to use my expertise to give people a voice to tell their stories."

The Ottawa, ON, native's high marks earned him the Frank Covert Scholarship, which is awarded to students who are among the top 10 in their first year of law school. The scholarship was established by Atlantic Canada's largest law firm, Stewart McKelvey, and honours the distinguished Halifax practitioner

who passed away in 1987. "When I learned that I received the award, it felt like a huge accomplishment," says Valsamis. "Frank Covert was a well-respected lawyer and a man of great integrity. Being awarded this scholarship made me want to live up to that standard."

In March, Stewart McKelvey announced that it is furthering its commitment to law students at UNB with a leadership gift of \$200,000. The gift enhances the existing Frank Covert and Stewart McKelvey scholarships, which are awarded to second- and third-year students who show promise in the profession. In addition, a portion of the gift will create a new scholarship for first-year students who represent diverse communities.

Dean of Law John Williamson (BBA'71, LLB'73) applauded the firm's support. "Stewart McKelvey's two upper-year scholarships are some of our most valuable renewable awards for students, and they represent just a portion of the support the firm provides for students like Niko. It is important to give our next generation of top lawyers a

great start, and Stewart McKelvey is helping us achieve that goal."

Of the new Stewart McKelvey Scholarship in Diversity, CEO and Managing Partner Lydia Bugden (LLB'91) says that the firm wanted to create an award that reflects many of its core beliefs. "As a firm, we value diversity and are committed to providing a workplace that fosters a culture of awareness, appreciation and respect. We also want law students to know that they are valued and that their perspectives and experiences matter."

As for Valsamis, he has no regrets about leaving his kickboxing career behind. "I've received a great education at UNB. The law school allows students to gain important soft skills as well as precise understanding of legal principles. This combination is fundamentally important to students starting a career in the legal profession. You don't find that at every law school."

Student support is a significant part of UNB's \$110-million fundraising campaign, *It Begins Here*. 🌱

Charles MacDonald takes care not to disturb the contents when flipping through a binder of correspondence he's collected from students that he's supported with scholarships at the University of New Brunswick.

His neatly-arranged compilation is packaged with information on the 13 students who have received the Patricia and Charles MacDonald Scholarship, each unique in their abilities and their aspirations.

Inside, there are thank-you letters, group pictures, news clippings and the annual financial update on his scholarship fund. It's a collection Charles treasures, both for his connection to the students and the university.

"It seemed like the right thing to do," Charles said of his investment. "Most of the people who get the scholarship are on the Dean's List and do some important community work. Hopefully, this gives them an opportunity."

Charles, whose family established roots in Fredericton more than 200 years ago, grew up on Charlotte Street, went to Smythe Street School and Fredericton High School. After graduation, he worked on the Mid-Canada Line designed to protect North America during the Cold War and later developed his technical skills aboard the *HMCS Restigouche* and *HMCS Bonaventure* during six years in the Royal Canadian Navy.

Charles and Pat married in 1967, shortly after his return to Fredericton. When their son Ian, (BSc, '90, BEd '91) attended UNB on a scholarship, they came to realize what this support means, not only to students but to families.

When Charles retired in 1990 with a portfolio of successful investments, he was in a position to make a difference. Although he did not graduate from UNB, he wanted to open doors for students and hopes his efforts will serve as inspiration for other community members, including those like him who have not attended UNB, to provide student support.

In 2010, he established the Patricia and Charles MacDonald Scholarship, which currently provides full-tuition support annually to three UNB students and will be enhanced by a bequest from Charles. In September, the scholarship will have supported 16 UNB students.
