**An Act to Amend an Act to Incorporate
The Clergymen of the Emmanuel Fellowship Faith
Under the Name of Emmanuel Fellowship**

WHEREAS The Trustees of The Emmanuel Fellowship has by its petition prayed that it be authorized to amend its Act of incorporation as hereinafter set forth;

AND WHEREAS it is deemed expedient to grant the prayer in the said petition;

THEREFORE, Her Majesty, by and with the advice and consent of the Legislative Assembly of New Brunswick, enacts as follows:

1 Section 8 of An Act to incorporate the Clergymen of the Emmanuel Fellowship Faith under the name of Emmanuel Fellowship, chapter 31 of 2 Elizabeth 11, 1953, is repealed and the following substituted therefore:

8 The annual meeting of the Corporation shall be held at its head office or at such other place in the Province or in Canada as the Trustees may determine, on a date to be fixed by the Trustees.
