An Act to Amend An Act Respecting Certain Parks and Streets in the City of Fredericton

WHEREAS the City of Fredericton prays that it be enacted as hereinafter set forth;

THEREFORE, Her Majesty, by and with the advice and consent of the Legislative Assembly of New Brunswick, enacts as follows:

- 1 Section 4 of An Act Respecting Certain Parks and Streets in the City of Fredericton, chapter 161 of 15 Elizabeth II, 1966 is amended by adding thereto immediately after subsection (5) the following:
- (6) Notwithstanding section 1 of the Act, the City of Fredericton may construct a public street upon that portion of the parcel of land mentioned in clause (vii) of Schedule A described as follows:

beginning at a point situate where the southerly limits of Cameron Court intersects the westerly boundary of the Murial Ashfield property, said described point of beginning having N.B. Grid Coordinate values of easting 286331.004 metres and northing of 739540.497 metres;

thence on an azimuth of 225° 54' 34" a distance of 10.473 metres to a point;

thence on an azimuth of 103° 57' 10" a distance of 8.875 metres to a point;

thence on an azimuth of 353° 23' 35" a distance of 9.490 metres to the point of beginning, containing an area of 39.4 square metres more or less;

Provided that

(a) Murial Ashfield conveys to the City of Fredericton the parcel of land described as follows:

beginning at a point situated where the southerly boundary of the Murial Ashfield property intersects the westerly boundary of the Odell Park lands, said point having N.B. Grid Coordinate values of easting 286390.335 metres and northing of 739455.034 metres;

thence on an azimuth of 289° 41' 38" a distance of 19.019 metres to a point;

thence on an azimuth of 68° 21' 20" a distance of 30.484 metres to a point;

thence on an azimuth of 210° 34' 10" a distance 20.503 metres to the point of beginning, said described parcel of land containing an area of 191 square metres, more or less;

(b) the lands in paragraph (a) above conveyed to the City of Fredericton are dedicated by the City of Fredericton as public park lands and become subject to the provisions of this Act.

thence on an azimuth of 103° 57' 10" a distance of 8.875 metres to a point;

thence on an azimuth of 353° 23' 35" a distance of 9.490 metres to the point of beginning, containing an area of 39.4 square metres more or less;

Provided that

(a) Murial Ashfield conveys to the City of Fredericton the parcel of land described as follows:

beginning at a point situated where the southerly boundary of the Murial Ashfield property intersects the westerly boundary of the Odell Park lands, said point having N.B. Grid Coordinate values of easting 286390.335 metres and northing of 739455.034 metres;

thence on an azimuth of 289° 41' 38" a distance of 19.019 metres to a point;

thence on an azimuth of 68° 21' 20" a distance of 30.484 metres to a point;

thence on an azimuth of 210° 34' 10" a distance 20.503 metres to the point of beginning, said described parcel of land containing an area of 191 square metres, more or less;

(b) the lands in paragraph (a) above conveyed to the City of Fredericton are dedicated by the City of Fredericton as public park lands and become subject to the provisions of this Act.
