**An Act to Amend an Act Respecting
The Charlotte County Hospital**

WHEREAS The Charlotte County Hospital prays that it be enacted as hereinafter set forth:

THEREFORE, HER MAJESTY, by and with the advice and consent of the Legislative Assembly of New Brunswick, enacts as follows:

1 *An Act Respecting The Charlotte County Hospital, Chapter 77 of 14 George VI, 1950, is amended by deleting subsection (1) and (2) of section 2 thereof and substituting therefor the following:*

2(1) From and after the passing of this Act, the affairs of the said The Charlotte County Hospital shall be managed and controlled by a Board of thirteen Trustees.

2(2) The said Board of Trustees shall be appointed in the following manner: seven of them by the Mayor and Council of the Town of St. Stephen; one of them by the Mayor and Council of the Town of St. Andrews; one of them by the Mayor and Council of the Town of St. George; and the remaining four of them, one of whom shall be a resident of the Parish of West Isles and one of whom shall be a resident of the Parish of Campobello, from residents of the rural areas of the County of Charlotte by the nine appointed as above.

CONSIDÉRANT que *The Charlotte County Hospital* demande l'adoption des dispositions qui suivent;

À CES CAUSES, SA MAJESTÉ, sur l'avis et du consentement de l'Assemblée législative du Nouveau-Brunswick, décrète:

1 *La Loi intitulée «An Act Respecting The Charlotte County Hospital», Chapitre 77 de 14 George VI, 1950, est modifiée par la suppression des paragraphes (1) et (2) de l'article 2 et leur remplacement par ce qui suit:*

2(1) From and after the passing of this Act, the affairs of the said The Charlotte County Hospital shall be managed and controlled by a Board of thirteen Trustees.

2(2) The said Board of Trustees shall be appointed in the following manner: seven of them by the Mayor and Council of the Town of St. Stephen; one of them by the Mayor and Council of the Town of St. Andrews; one of them by the Mayor and Council of the Town of St. George; and the remaining four of them, one of whom shall be a resident of the Parish of West Isles and one of whom shall be a resident of the Parish of Campobello, from residents of the rural areas of the County of Charlotte by the nine appointed as above.
