





# NEW BRUNSWICK PETROLEUM GRID MAP




# PRINCE EDWARD ISLAND PERMIT GRID MAP



# PEI OIL AND NATURAL GAS ACT

89

242. Insofar as Prince Edward Island is concerned, its oil and gas legislation references the fact that the limits of its offshore jurisdiction must be established by a future federal-provincial agreement. The Prince Edward Island *Oil and Natural Gas Act* contains a verbal definition of the offshore area within the province's jurisdiction which does not correspond to the Stanfield line. Section 2(p) of the Act defines "provincial lands" as follows:


(p) "provincial lands" means the land mass of Prince Edward Island and includes the seabed and subsoil off the shore of the land mass to the limits of Prince Edward Island sovereignty and to such limits as may be set by federal-provincial agreement; (emphasis added)<sup>73</sup>

243. Thus, the practice of other provinces, which in any event does not support Nova Scotia's contentions, is irrelevant.


## QUÉBEC APPLICATION OF 1964 AGREEMENT BOUNDARY



Permits 1965-1971







## NS EXPLORATION PERMITS 1965-1970s

- Newfoundland never objected to this practice
















The Katy Industries







# 135° AZIMUTH ON CONIC PROJECTION















# KATY PERMIT WITH POINTS 2016 & 2017



Projection Chart






1973 to 1975







# THE SCOPE OF NFLD PERMIT RIGHTS

## *Statutory Provisions*

### **Newfoundland Petroleum and Natural Gas Act s.8 – 1966**

- 8(1) ...no person shall drill or operate or undertake to drill or operate any well, except in accordance with a subsisting licence, permit or lease...

### **Newfoundland s.8 - 1974**

- 8(1) ...no person shall undertake or commence any operation relating to the exploration for or exploitation of petroleum within the jurisdiction of the legislature, except in accordance with a subsisting licence, permit or lease.

## THE SCOPE OF NFLD PERMIT RIGHTS

### *Newfoundland's Attitude To Seismic Permits*

**"In most countries... companies carry on this seismic surveys prior to even making an application for the right to drill and produce. A number of companies may conduct separate seismic surveys over the same area and of course, only one company is awarded the right to drill and produce.**

**"Thus, in most countries, the carrying out of seismic surveys is considered to be a normal part of the process of determining (sic) whether a company is interested in an area, and is not considered to entitle a company to any special rights in the area in question. This will also be the position of this Government."**

### *Issuance of Seismic Permits By Newfoundland*

This amendment [1974] was aimed at regulating pre-drilling seismic surveys **and obtaining the information generated therefrom.** Pursuant to the amended Act, any company wishing to conduct, say, seismic operations on Newfoundland's continental margin **must first present a general program description** to the Department of Mines and Energy. **After review, an interim permit is issued** subject to the usual conditions...



## SUMMARY AND CONCLUSIONS



The permit behaviour of the parties is highly relevant

- “From 1964 until 1984, the issuance of permits by Newfoundland and Labrador was part of the province’s strategy **to assert exclusive jurisdiction over all of the offshore resources adjacent to its coasts.**”



- The *1964 Agreement* boundary survived Federal “Rejection”
  - The parties continued to view themselves as bound by the Agreement
- The boundary was applied despite the failure to gain full ownership and jurisdiction

## SUMMARY AND CONCLUSIONS

- The supposed “preoccupation with the gulf” is not evident in the permit activities of Nova Scotia and Newfoundland
- The 135° line was applied by Nova Scotia and Newfoundland in their permit issuance
  - This practice preceded the alleged 1984 invention of the line by many years
