#### Dear colleagues and friends,

Warm greetings from the University of New Brunswick, Saint John.

November 20th marked World Children's Day, and this year marks the 33rd anniversary of the UN General Assembly's adoption of the <u>Convention on the Rights of the Child</u>. As we celebrate this important day and reflect on the achievements made in securing children's rights over the past 33 years, we must also reflect on the work that must continue. With this in mind, I am pleased to share with you the progress we have made in the GlobalChild program.



To begin, I am delighted to announce that I have been appointed a Chair in Child Rights and Child Development at the University of New Brunswick's <u>Integrated Health Initiative</u>. I look forward to working closely with this initiative and continue sharing the message of the importance of child rights and child development. The GlobalChild platform has also made significant progress, with a

successful launch event last December and plans to pilot the platform both abroad and here in Canada. Our InspiRights project has launched its first series of surveys, gathering nominations of good practices from across North America. I am excited to share that we have begun to process of creating a Child Advisory Board for GlobalChild, ensuring that children will have the space and opportunity to be involved with the work and we research we conduct. I invite you to read more about each of these projects in the sections below.

Last but definitely not least, the world is becoming an increasingly difficult place for children to survive and thrive. On this sombre note, I would like to acknowledge the killing of children by the Islamic Republic of Iran. As citizens have engaged in protests for their freedom, the dictatorship in place in Iran has killed more than 60 children between the ages of 9-18 years old over the past few weeks. These horrific actions are a stark reminder that much work remains to be done in securing a safe and secure today and tomorrow for <u>all</u> children.

## InspiRights: Call to Participate in an Exciting Global Study

<u>InspiRights: Good Practices to Inspire and Facilitate Children's Rights</u> is a 5-year project that will take an inventory of good practices that inspire children's rights around the world and share these practices with an international audience. In collaboration with a consortium of eight universities and international and regional agencies, InspiRights will compile a list of good practices (legislation, policies, and programs that promote the implementation of children's rights under the CRC) and publish the list as a stand-alone resource.



Beginning with a North American survey, InspiRights will gather information from governments, organizations and individuals seeking to nominate a good practice. Following the completion of the North American Pilot survey, the InspiRights project will move forward with launching its Global survey. The success of this project will depend on the extent to which the survey has been shared and responded to by experts in children's rights policy and programming worldwide. We invite you to follow our social media to keep up to date on the project.

Currently, the InspiRights project's North American survey is open and available for participants to nominate good practices. We invite you to participate in the survey.



## **GlobalChild's New Brunswick Child Advisory Board**

With the generous funding of the New Brunswick Health Research Foundation's Research Related Support Fund, the GlobalChild team has initiated the development of a Child Advisory Board in New Brunswick, Canada. The Child Advisory Board will consist of a group of New Brunswick children who will discuss and provide feedback on the GlobalChild's various projects and participate in knowledge translation activities. The GlobalChild team is excited to move forward with this project and looks forward to beginning recruitment for the Child Advisory Board in the upcoming months.





## **Celebrating the Canadian Launch of the GlobalChild Platform**

The GlobalChild Platform was launched online to a Canadian audience on December 13th, 2021, commemorating the 30th anniversary of Canada's ratification of the Convention on the Rights of the Child. We were honoured by the support of 5 former UN Chairs of the Committee on the Rights of the Child who spoke during the webinar, as well as the opening by Honourable Landon Pearson O.C. This event was generously funded by the Social Sciences and Humanities Research Council (SSHRC) through a Connection grant.

The Canadian Launch was a huge success with almost 500 researchers, advocates, government officials, NGOs, and civil society members from across our vast country, and around the world, in attendance. We sincerely appreciate the support from our partners who promoted for this significant event, as well as all those who worked behind the scenes to execute it. #### Launching the Belgium Pilot of the GlobalChild Platform

Following the success of the Canadian Launch of the GlobalChild Platform, <u>Belgium's National Commission on the Rights of</u> <u>the Child</u> expressed interest in piloting the GlobalChild Platform. Following weeks of dialogue, and with the approval of Belgium's Intergovernmental Working Group on the Rights of the Child, GlobalChild's <u>Steering Committee</u> designated Belgium to be the first international jurisdiction to pilot the GlobalChild Platform.

The <u>BE-Pilot of GlobalChild</u> will take an inventory of the structures and processes in place in Belgium to support the substantive rights of children under the CRC using the indicator sets that align with the areas of concern identified in the UNCRC's last Concluding Observations. The collected data on these structures and processes through GlobalChild will inform Belgium's 2024 report to the United Nations Committee on the Right of the Child.

The BE-Pilot is being conducted in close partnership with Belgium's National Commission on the Rights of the Child.

## Publication of Open Access Book with Springer

The GlobalChild Indicators Development Team (IDT) has published an open access book: <u>Monitoring State</u> <u>Compliance with the UN Convention on the Rights of</u> <u>the Child: An Analysis of Attributes</u>. The book documents the outcome of the first phase of our methodology in developing the indicator sets of the GlobalChild platform: identifying the key attributes of all substantive rights of children under the CRC. Containing a wealth of information on every substantive right under the CRC, this book offers an invaluable reference guide for researchers and students in the field of childhood and children's rights studies, as well as a wide range of professionals and organizations concerned with the subject.

#### Preparing the New Brunswick Pilot of the GlobalChild Platform

Preparations for the <u>New Brunswick Pilot of GlobalChild</u>, the first pilot region in Canada, are currently underway. A meeting to determine the members of this steering committee will take place in early December 2022. In 2023, data will be collected in New Brunswick on the strengths and gaps in government capacity to fulfill all 41 children's substantive rights under the Convention on the Rights of the Child. This pilot is being conducted in close partnership with the <u>NB Office</u> <u>of the Child and Youth Advocate</u>. #### HEAL 3005: Child Health and Child Rights at the University of New Brunswick

GlobalChild has created new course under the Integrated Health Initiative called HEAL 3005: Child Rights and Child Health. The first of its kind in New Brunswick, HEAL 3005 is an exciting new health course that focuses on children's human rights and their relationship with children's health and development. Undergraduate students had the opportunity to engage in critical thinking about human rights and their impact on children's lives, child-focused practices, and policy development across disciplines during the inaugural offering of this course at UNB in May 2022. This is a unique course that can serve as an elective for students from diverse fields such as: pre-med, pre-law, any health-related programs, or social-science branches and will be offered annually.


