



The 2021 UNBF Great Bike Giveaway

UNB Sustainability has partnered with Savage's Bicycle Centre to offer **refurbished** bicycles that were previously abandoned or donated. These bikes will be given away during the 2021-22 academic year to eligible UNB Fredericton students.

Please read the rules and regulations below carefully to determine program eligibility.

Due to the limited number of available refurbished bicycles, program eligibility will not guarantee award. Bicycles will be handed out on a case-by-case basis to the winner(s).

Eligibility

Eligibility is restricted to **full-time UNBF students** with demonstrated financial need. Students must also be in good academic standing (GPA of 2.0 and over from the most recent assessment year) to be eligible for program consideration.

Procedures and Implementation

Step 1: Complete the attached budget sheet.

Budget sheet is obtainable through the UNBF Financial Aid Office located on the 1st Floor, CC Jones Student Services Centre or on-line through the Financial Aid website.

Step 2: Complete the “Release Section**” of the Great Bike Giveaway application before submitting the complete application to the Financial Aid Office.**

****Please note** that UNSIGNED applications will **NOT** be considered.

Step 3: The UNBF Financial Aid Office will review “**completed**” applications and send a list of eligible applicants to UNB Sustainability who will further screen based on the sizes of bikes available that year.

Step 4: UNB Sustainability will select the recipient(s) during the first week of October 2021.

Great Bike Giveaway Winners will be contacted to arrange a time to obtain their bike. There is the potential for further bikes to be awarded throughout the year depending on availability.

"Release Section"

WHEREAS UNB Sustainability has agreed to gift refurbished bicycles (the "Gift") to those students as identified by UNB Sustainability;

AND WHEREAS the undersigned releasor agrees to accept the Gift on an "as is where is" basis;

The Releasor acknowledges:

- a. Program eligibility will not guarantee an award;
- b. The Financial Aid Office of the University of New Brunswick may review the Releasor's academic transcript to verify academic standing;
- c. The Financial Aid Office may use the application information to determine program eligibility;
- d. The information provided on the budget and/or application form is true to the best of the applicant's knowledge;
- e. Specific budget data and further financial information will not be released to UNB Sustainability;
- f. If selected as a winner, the Releasor shall receive notice of such in writing and shall make immediate arrangements to obtain and/or collect the refurbished bicycle; and
- g. In the event that the Releasor does not obtain or make arrangements for collection of the refurbished bicycle within one month of receipt of the notice, UNB Sustainability may deliver the refurbished bicycle to another applicant.
- h. If unable to take the bike home, we ask that the Releasor donates the bike back to the program to be made available to future students.

The Releasor has reviewed and understands the NB Cycling Laws and Regulations.
