### Director Report 2023-2024

In my first year as Director, we were finishing up a strategic planning exercise. Rina Arseneault, the Associate Director, and I came up with three key messages concerning our mandate: 1) The MMFC is part of the solution to family violence in Atlantic Canada; 2) The importance of always being attentive to victims/survivors of family violence, policy makers, service providers and communities; and 3) The context and forms of family violence are constantly shifting; therefore, we also need to shift. These messages remain relevant, and the last one reminds us to be flexible and responsive to change. Change was constant during the 2023-2024 year at the MMFC, my last year as Director.

We engaged with a variety of leaders of change including Lynne Groulx, the CEO of the Native Women's Association of Canada, Cheyanne Joseph, Piluwitahasuwin and Associate VP Indigenous Engagement at UNB, the Honorable Brenda Murphy, Lieutenant Governor of New Brunswick, Nadia Richards, Associate VP Human Rights at UNB, Donatha Gihana, founder and CEO of Rwanda Esther's Initiative and Leanne Fitch, former Chief of the Fredericton Police Force and member of the Nova Scotia Mass Casualty Commission. Rates of family violence continue to rise globally. These conversations centred around the adverse impacts of family violence on members of vulnerable populations and the need for equitable access to interventions that provide safety and healing. All researchers associated with the MMFC are engaged in applied research with community partners to improve interventions and policy. This includes a growing and important research focus on men's experiences of violence.

Our approach to education has evolved. This year we saw the expansion of online course offerings in the Family Violence Issues Certificate Program. It is now possible to complete the Certificate in-person, hybrid or fully online. Enrolment in our online professional development training in Essential Skills for Interviewing Children continues to grow.

With Peter Titus, our new Communications Officer, we continue to hone our communications strategy, translating research findings into accessible formats for a variety of audiences. The MMFC has a growing presence on Facebook, Instagram, YouTube and X/Twitter and, along with our quarterly e-news, keep stakeholders up-to-date and connected to further information on our website.

As always, this annual report is packed with rich information about the research, education and knowledge transfer activities of everyone associated with the MMFC. I am grateful to the Fergusson Foundation and UNB for funding the operations of the MMFC, the staff, and the members of the Board of Directors for their work, advice and support.



#### **Achievements:**

I work collaboratively with police organization, the NB Department of Justice and Public Safety, and John Howard Society of New Brunswick on diverse research and consulting projects. In the context of Family Violence research, I have provided training to probation officers and victim services professionals for the NB Department of Justice and Public Safety earlier this year on the dynamics of IPV, its risk factors, and intervention services for perpetrators of violence to reduce IPV behaviour, as well as the importance of safety planning and risk mitigation for the safety of the survivor of this violence (see below for workshop titles).

We will be using the data obtained from the CELIA research project on the ODARA and police response to IPV in the coming year to advise the policing sector on training needs for improving police response to IPV. In collaboration with Inspector Mike Young with the Saint John Police Force, we have developed a Research Advisory Committee within the structure of the NB Association of Chiefs of Police to provide a direct conduit for knowledge dissemination and mobilization, as well as research development, within the policing sector on diverse criminal justice topics, including IPV and Family Violence more broadly in New Brunswick.

As new Project Coordinator, I cannot speak to activities in the previous year; however, the upcoming year will see:

- The A2A aims to develop a web-based family violence assessment guide for use by family law practitioners and service providers across Canada. This year will see the training and pilot roll-out of the risk assessment tool.
- Regional CoP (communities of practice) meetings will also continue meeting virtually. Meetings have been scheduled for June 2024, September 2024, and January 2025. CoP's will assist in testing the draft tool and providing feedback.
- Additional project deliverables will also be completed, including a webinar on the topic of policing coercive control and risk assessment (June 5, 2024), and a research brief on the considerations of cultural minorities and family law needs (Aug 31, 2024).

The project is part of a national initiative to establish five regional "Communities of Practice" (CoP), bringing together experts and key stakeholders to develop multi-disciplinary approaches to addressing family violence in Canadian family court systems. The project has been funded by the Public Health Agency of Canada with a total of 1.2 million dollars (split among the five regional centers) for a 3 year period.

The focus of each CoP is enhancing the capacity of family law practitioners to address family violence safely and effectively. The project began with the creation of a local CoP and expanded to include provincial (Year 2) and regional (Year 3) members. The MMFC-affiliated CoP now has members from all four Atlantic provinces, including family law lawyers, indigenous domestic violence workers, transitional housing workers, police officers, academics, medical practitioners, social workers, domestic violence trauma counsellors, and support service workers for youth and newcomer populations, including immigrant and refugee women.

During the reporting period, the project hosted four CoP meetings and two webinars. Each webinar was given accreditation for CPD (continuing professional development) hours by the Law Societies of NB, PEI, Newfoundland, and Nova Scotia. The first webinar (held in September, 2022) had 311 registrants and 236 in attendance. The second webinar (held in November, 2022) had 126 registered and 52 in attendance.

The project also published two research briefs during the reporting period and one legal bulletin. These publications are posted to the project website and made available in both official languages.

Members of the CoP and the project coordinator were invited presenters at the Nova Scotia Access to Justice Week on October 28, 2022 and spoke to the challenges that survivors of family violence face in family court proceedings.

The Department of Justice – Restorative Justice & Courtroom Experience projects entail the production of immersive 360-degree video educational resources to build knowledge of trauma-informed justice services and processes. This style of media has the potential to generate a powerful and dynamic sense of immersion, allowing viewers to interact with the environment and gain a better understanding of the geography of a space. It also provides the audience with the agency to choose which visual information to access, and when to access it. In collaboration with the New Brunswick Department of Justice and Public Safety, the team is working on two projects, Restorative Justice and Courtroom Experiences, respectively. Both projects provide accessible digital media in both French and English.

The first project involved the creation of an educational resource that provides immersive learning about Restorative Justice practices. There is a growing interest in adopting restorative justice approaches in New Brunswick, but because there are some barriers to its implementation, the project focused on awareness and promotion of the program with the use of 360-degree media. The goal of this project was to address gaps in understanding about principles of Restorative Justice, to demystify common misconceptions related to it by allowing audiences to experience an example of it, in an immersive way. Theater and film actors were hired to recreate a Restorative Justice circle, allowing the audience to see who participated, and what to expect from the process. Team partners from the Department of Justice and Public Safety: Victim's Services Branch have reached out to audiences both digitally and through in-person workshops and presentations. The resources were distributed on a government website, shared by potential clients when considering participation in Restorative Justice processes, is a part of e-learning modules, and is used in live professional learning contexts.

The Courtroom Experience project was a part of a bigger initiative focused on Trauma Informed Justice Practices in New Brunswick. The approach was to create 360-degree immersive videos to educate audiences about the court houses virtually, before they physically arrive at the space. The goal is that, by providing the public with a guided virtual tour of the space, it will help to reduce the fear and anxiety of individuals who will be entering the facility. Through narration, text cues, and additional information, viewers will be able to gain a better understanding of the court, its functions, and its processes. The Court of Kings bench and the Provincial Court were the two courts scanned in Moncton. The team hopes that providing this immersive learning experience for victims, prior to arriving at the court for the first time, can mitigate intimidation, anxiety, and stress. This footage has been converted into a single immersive tour experience as well as a series of short videos which are set to be completed by the end of the summer, and later be distributed as online resources.

The research team, overseen by Dr. Matt Rogers, is engaging in theoretical and methodological analysis of these projects, tracking their implications from their envisioning to their distribution. With the near completion of these initial projects, the team is now developing various new educational resources in the same vein as these projects.

#### Activities

The Muslim Family Safety Project is a collaborative partnership which began in 2019 between the Religion and Violence Research Team of the MMFC, the Arabic Cultural Centre (ACC), and the Muslim Resource Centre for Social Support and Integration (MRCSSI) in London, Ontario. The Project's Advisory Committee includes representatives from the Fredericton Police Force, Liberty Lane Domestic Violence Outreach, and the GNB Department of Social Development. The project aim is to build bridges of understanding between Muslim and Arab families and providers of public family violence services in the Fredericton area.

The ACC worked closely with staff of the MRCSSI to support a Muslim family whose children were in the care of GNB's Child Protection services. The new Child and Youth Well-Being Act specifies that child protection services will include consideration of kin, culture, ethnicity, heritage, traditions and spiritual beliefs. It promotes collaborative approaches to engage with family and other persons who have connection to children and youth and prioritizes their placement in the care of people who share their language, culture heritage or religion.

Staff from the MRCSSI facilitated the virtual delivery of the Strengthening Families Program (SFP) to this family with the support of the research team. The SFP is a 14-session, evidence-based program designed for families who are vulnerable to violence. The program is culturally adapted to help immigrant family members learn and practice parenting skills, social skills and life skills together. SFP aims to reduce problem behaviours, delinquency, alcohol and drug use by children and youth, and to improve communication and performance in school. Each session of SFP included separate classes for parents and children as well as a family practice class.

Abir Al Jamal conducted an in-person FAST (Four Aspects Screening Tool) Assessment of all members of the family and a report on the findings along with recommendations were shared with all Social Development staff and child protection workers.

Information from the research team's activities with this family were included in briefs presented at settlement conferences and pre-trial meetings concerning the care of the children.

#### Activities

We have collected data from a large U.S/Canada wide survey of 3,100 young men. The first presentation of the data was made at Griffith University, Gold Coast, Australia in April 2024.

The projected is oriented toward helping reduce rates of sexual assault among young people, and this research represents one of the first investigations to examine undetected men's assault of women using online anonymous tools to explore these reports in depth.

We have captured insights into assaults in young men's own words, and we believe that this research will yield important outcomes for research and training, practice, and societal well-being, raising public awareness of sexual assault to a new level. Additional findings will be presented at the annual meeting of the Society for the Scientific Study of Sexuality in November, San Diego.

#### **Project Start-up activities:**

The research coordinator and research assistants were hired. The core research team developed the project procedures and expected timelines, and a regular meeting schedule was developed for both the core research team (i.e., weekly) and the full research team/collaborators (i.e., monthly). Research ethics applications were submitted and approved by the following institutions: Dalhousie University, University of New Brunswick, Universite de Moncton, University of Prince Edward Island, and Saint Francis Xavier University. All study materials and data collections tools were translated to French.

#### **Program Development Activities:**

The intervention used in the AIM Program was adapted from a study conducted in Taiwan to be used in the Maritime context with women in midlife and older. The facilitator training program and materials were developed in English and French.

#### **Community Engagement Activities:**

A list of community-based organizations in the Maritimes was compiled that included several IPV-related service-delivery organizations, such as transition houses, second-stage houses, domestic violence outreach programs, and other organizations that target women (e.g., women's centres, addiction programs for women, sexual assault centres).

#### **Community Engagement Activities:**

Organizations that provide services to diverse women in the Maritimes (e.g., Francophone women, immigrant women, Black women, Indigenous women) were also identified to help reach marginalised populations. Emails were sent to the list of organizations to inquire about forming a research partnership. Virtual meetings were set up with the Executive Directors of organizations who responded with an interest in developing a partnership. Organizations were provided with information about the study and were asked if they would be interested in helping with participant recruitment and implementation of the AIM Program.

Organizations were offered two partnership options. Partnership 1 involved the organization appointing a staff member to serve as a program facilitator who could help recruit participants and deliver the intervention to the participants. The facilitators were asked to participate in a two-hour virtual training session on how to deliver the AIM Program. Organizations that agreed to this partnership were provided with a \$3500 payment to compensate them for overhead fees and staff time. Partnership 2 involved the organizations being asked to spread awareness of the study and to help with participant recruitment. A \$500 payment was provided to organizations for agreeing to this partnership.

#### **Program Implementation & Data Collection activities:**

A total of fifteen community-based organizations throughout the Maritime provinces partnered with the project. Six research staff members were also hired to be program facilitators. Fifteen professionals took part in the facilitator training program. A total of 39 participants have been enrolled in the study to date. Baseline data has been collected with 38 participants and follow-up data has been collected with 2 participants. 21 participants have been randomly assigned to receive the AIM Program and 17 participants have been randomly assigned to the comparison group. Two participants have completed the AIM Program to date, and eighteen are currently in the Program.

Funding from the Public Health Agency of Canada was used to conduct a pilot of the Kid's Club Mom's Empowerment (KC & ME) interven¬tion program for children exposed to D/IPV and their mothers at the Courage Centre in Shediac and at Liberty Lane in Fredericton. The Muriel McQueen Fergusson Centre for Family Violence Research (MMFC) was contracted to evaluate the pilot through pre- and post-program (completion and six months after completion) data collection with questionnaires in French and English.

Following approval of an application for review of research involving humans by the UNB Research Ethics Board, data was collected from mothers and children who participated in three KC & ME groups each in Shediac, Moncton and Fredericton that included Francophone, Anglophone and immigrant families. Cathy participated regularly in the Advisory Committee meetings for the pilot project. Data analysis is proceeding.

#### Activities

The past year has been a year of significant productivity despite the previous constraints of the pandemic. Our book has come out and we have made important academic, community and media reports of the work of our Creating Peaceful Learning Environments (CPLE) Team.

This past three years had been unique in the history of the CPLE team as a result of a significant alteration in the manner in which it has been able to conduct its activities. We have operated in both New Brunswick and British Columbia with the vastly helpful assistance of digital information systems for the past year, so all of our work has been conducted on line, bringing both benefits and challenges. One of our most exciting projects has had to be put on hold because our participating New Brunswick Indigenous family was hit hard by covid-19 and had not been in a position to continue with us and will not be available until recovery from the pandemic. But another project with refugee Rohingya children is India and Bangladesh is moving slowly forward, and our Confidence in Communications dissemination project supported by the MMFC has also developed slowly as a result of schools' irregular attendance procedures. It will move forward next year.

Our team undertakes numerous quasi-ecological projects around the globe, focusing on resilience of toddlers, kindergarten students in the transition to school, most recently in western Canada and Brazil as well as eastern Canada, youth and independent elderly adults in Switzerland, Lithuania and eastern and western Canada, webring to light findings regarding gendered factors in youth perceptions of intimate relationships and the influence of digital media and relationships. All of these projects are reported as listed below.

Ann Cameron coordinates research in collaboration with CPLE team members including current and past UNB and UBC graduate and undergraduate students. Latest initiatives involve: 1) former UNB doctoral student, Kang Lee, a SSHRC grant-supported cross-cultural study of academic integrity; 2) the new collaborative study in both British Columbia and New Brunswick with Anne Hunt of the reciprocal learning and teaching of Indigenous knowledge and cultural practices with older and younger non-Indigenous elementary school students and their teachers; 3) the study of pro-sociality of Rohingya children in mega-camps in Bangladesh; and 4) the Muriel McQueen Fergusson Foundation-funded knowledge-dissemination initiative with youth facilitating Confidence in Communications.

We continue to publish and present team findings in community and academic forums nationally and internationally. Our work to date has had an impact on the communities we contribute to by highlighting the importance of gender- and culture-sensitive violence-prevention analyses and interventions. Implications are of significance for schools' violence prevention work, socio-emotional development and international youth resiliency.

# Research fellows

**Dr. Alexa Yakubovich** is an Assistant Professor in Community Health and Epidemiology at Dalhousie University (cross-appointed in Gender and Women's Studies) and Affiliate Scientist with Nova Scotia Health. Dr. Yakubovich's mixed-methods research program includes investigations of the social and structural determinants of violence against women and the design and evaluation of interventions that account for these determinants. She received her PhD in Evidence-Based Social Intervention from the University of Oxford as a Rhodes Scholar and completed her postdoctoral fellowship, funded by the Canadian Institutes of Health

**Dr. Casey Burkholder** is an Associate Professor at the University of New Brunswick, interested in critical teacher-education, and participatory visual research. In choosing a research path at the intersection of resistance&activism, gender, sexuality, DIY media-making, art production and participatory archiving, Casey engages in research for social change through participatory visual approaches to local issues with youth and pre-service teachers. She is the co-founder of the Fredericton Feminist Film Collective, and is the co-president of the Language & Literacy Researchers of Canada (2021-2023).

Dr. David Hofmann is an Associate Professor of Sociology and the Director of the Criminology and Criminal Justice Program at the University of New Brunswick Fredericton Campus. He is a nationally-rec-ognized expert on far-right extremism and violence, and has extensive experience conducting funded research in this area with governmental partners such as Public Safety Canada, National Defense, and Defense Research and Development Canada. He is the co-lead on the multi-year government funded Network for Research on Hateful Conduct and Right-Wing Extremism in the Canadian Armed Forces which is studying the breadth, depth, and extent of far-right worldviews and ideologies in the Canadian military. David is also a research fellow with the Gregg Centre for the Study of War and Society. David's current research intersts are focused on five broad areas: terrorism and political violence, charismatic leadership, right-wing extremism, apocalyptial and millenarian groups, and criminal. David is a mixed methodologist, with a particular interest in social network analysis. Given the culture of toxic masculinity that often goes hand-in-hand with groups and individuals involved in right-winged extremist groups, it is an environment where Intimate Partner Violence/ gendered violence is likely to thrive. David is interested in incorporating an exploration of the relationship between right-wing extremism and IPV/gender violence into his research.

**Dr. Diane Crocker** is a Professor and Chair in the Department of Criminology at Saint Mary's University in Halifax. Diane's research focuses on gender-based violence and restorative justice. In recent years most of her research has addressed campus sexual violence policies and domestic violence prevention.

**Dr. Evie Tastsouglou** is a Professor at the Department of Sociology, cross-appointed to the International Development Studies Program at Saint Mary's University in Halifax, Nova Scotia. With sociological and legal training Dr. Tastsoglou has over twenty five years of expertise in working with gender and immigrant women in Canada and internationally. As founder and leader of the Gender Domain of the Atlantic Metropolis Centre of Excellence (2003-2013) she led multiple projects on various aspects of migration with a gender-based and intersectional analysis. Past Chair of her Department (2006-2012), President Elect and subsequently President of the RC 32 ("Women in Society") of the International Sociological Association (2006-2014), member of the ISA Executive Committee and Research Council (2014-2018), and current President of the Canadian Ethnic Studies Association, she focuses her research on sexual and gender based violence and precarity during forced migration.

Dr. Tastsouglou is currently the Principle Investigator on the GBV-MIG Canada Research Team Project: Violence Against Women Migrants and Refugees: Analyzing Causes and Effective Policy Response

**Dr. Karla O'Regan** is an Associate Professor of Crim-inology at St. Thomas University and a parttime lecturer in the Faculty of Law at UNB. A graduate of St. Thomas University, Karla has law degrees from the University of Toronto, Dalhousie University, and the London School of Economics. She is a member of the Law Society of Upper Canada and has worked for the Federal Department of Justice, Ontario's Office of the Children's Lawyer, and private legal sectro.

Dr. O'Regan is the research lead of the Atlantic region for the Awarness to Action Porject.

**Dr. Laura Winters** is now CEO of Stella's Circle in St. John's, NL, which provides services to adults who face barriers to fully participate in their community including mental health challenges, addictions, trauma, poverty, homelessness criminal justice involvement, low literacy and unemployment. Their services include a residential counselling program, a housing resources centre, a women's centre, and a social enterprise training program. Stella's Circle is in the process of developing 15 units of transitional housing for women, prioritizing women experiencing homelessness who have histories of criminal justice involvement and/or experiences of violence. They also participated in the recent premiere's roundtable on gender equity and have engaged with the province's consultations on the Interpersonal Violence Disclosure Protocol Act.

**Dr. Lucia O'Sullivan** is a social psychologist and Professor in the Department of Psychology at the University of New Brunswick. She is also the director of the Sex and Relationships Lab. Her work focuses primarily on sexual health, intimate relationships, and the affective and cognitive components of sexual decision-making of young adults and adolescents. She held a Canada Research Chair in Adolescents' Sexual Health Behaviour (2006-2016) and has received a wide range of funding from federal agencies (e.g., NIH, CIHR, SSHRC) and private foundations (e.g., Ford, NBHRF) to support her work. Other studies address the development, maintenance, and breakup of intimate relationships, as well as the role of gender in romantic and sexual experiences. Dr. O'Sullivans research program frequently incorporates studies and collaborations that are international (e.g., South Africa, Guatemala, India, US, UK) and interdisciplinary.

D. O'Sullivan is Principle Investigator on the project: Identifying Scripts and Norms Guiding Young Men's Use of Sexual Aggression Against Women.

**Dr. Linda Neilson** is a Professor Emerita at UNB. Linda is a lawyer and a recognized academic authority on legal systems and family violence. Throughout her career, Linda's research has been devoted to legal system analysis and reform. Major works include, on behalf of the National Judicial Institute, three editions of a domestic violence bench book for Canadian Judges and, more recently, Responding to Domestic Violence in Family Law, Civil Protection and Child Protection Cases, published by the Canadian Legal Information Institute on the same topic. She is coeditor of Ending Gender-Based Violence (Captus Press, 2023). Her 2023 Family violence Family law brief (EN ; FR) examines social and institutional barriers in the legal system that prevent access to justice. She is the author of Parental Alienation Empirical Analysis: Child Best Interests or Parental Rights? (FREDA) and co-author, with Susan Boyd, of Interpreting the New Divorce Act, Rules of Statutory Interpretation and Senate Observations (FREDA and LEAF websites. Refer to LEAF for the document in French). She is author of a report on responding to family violence cases in multiple court systems from a family law perspective published by Justice Canada (ENG, FR). She was co-principal investigator (with Joanne Boucher) and with Justice Robichaud and Judge Dugas-Horsman of the Coordinated Provincial/Queen's Bench Family Violence Court Model project. Final Report: EN FR . In addition, she was the lead author of the (2019) Collective Memo of Concern to the World Health Organization on parental alienation endorsed by experts from 26 countries. In 2021 and 2022 she was the recipient of national and provincial awards for her work in the family violence field. She is a member of an international research team (led by Dr. Simon Lapierre, University of Ottawa). She initiated the formation of an international association of experts (Australia, Brazil, Canada, France, Germany, Israel, Italy, Netherlands, New Zealand, United Kingdom, United States) conducting research on family law issues associated with parental alienation concepts. Her academic work is cited by the United Nations Special Rapporteur in the (2023) violence against women and children report delivered to UN Human Rights Council (ENG, FR).

**Dr. MaryAnn Campbell** (Ph.D. Dalhousie) is a Full Professor in the Psychology Department at the Saint John Campus of the University of New Brunswick. Her main area of research focuses on deveoping and enhancing the application of evidence-based strategies for crime prevention and reduction. To date, Dr. Campbell's research has included the study of criminal behaviour committed by adults, youths, and and special populations (e.g., persons with mental health issues); understadning the psycopathic personality through its measurement in offenders and general populations; enhancing positive outcomes for justice-involved youth through evidence-based practice; and the evaluation of intervention programs aimed at crime prevention and risk reduction goals (e.g., mental health courts, chronic offender interventions, drug-treatment programs). Another related area of interest pertains to police psychology. Dr. Campbell has been involved in projects evaluating the implementation of intelligence-led policing, application of community policing principles, and the enhancement of best practices in police work (e.g., police responses to intimate partner violence, credibility assessment methods).

Dr. Campbell is the Principle Investigator for the Centre for Criminal Justice Studies & Policing Research – among other criminal justice topics. Her research centre has various projects on I PV-related themes:

a) Celia Project – Common language for Evidence-based policing and Levels of risk in IPV Assessment (SSHRC funded, PI Dr. Zoe Hilton) – She is a co-investigator on this project and coordinate the NB site involved in this project.

b) Police Views of the ODARA – a qualitative study examining police officers' views of risk assessment tool for appraising risk of IPV on the frontline in their calls for service led my Amy MacQuarrie, PhD Student, UNB Saint John Psychology (supervisor on this project) c) Police response to IPV and its association with violence risk mitigation

d) Assessing the properties of a psychopathic-borderline personality trait-based risk assessment tool for the prediction of IPV and severity of IPV behaviours based on police records.

**Dr. Mary Aspinall** is an Assistant Professor at St. Thomas University. Her research interests are intimate partner violence and therapeutic jurisprudence. She previously worked at the YWCA Isabel Johnson women's shelter, and as a Domestic Violence Victim Caseworker at Family Service Regina. She also served as a

panel member for the Saskatchewan Domestic Violence Death Review until her relocation to New Brunswick.

Dr. Aspinall is the Project Coordinator for the Awarness to Action (A2A) Project.

**Dr. Mayme Lefurgey** holds a Ph.D. in Gender, Sexuality & Women's Studies (collaborative program in Transitional Justice & Post-Conflict Recconstruction) from Western University. Mayme's doctoral research explored trauma-informed, relation-al and embodied approaches to addressing violence—including wartime violence, structural/systemic violence, family violence and gender-based violence in post-conflict Colombia in collaboration with the non-profit peacebuilding organization Dunna.

Mayme is UNB's Purdy Crawford/TD Bank Fellow in Accessibility (2021-2023)—a fellowship that supports applied research with immediate public policy relevance and impact on the lives of New Brunswickers. Her research considers the urgent need to understand how different forms of inequality intersect with and interact within the socio-political and economic contexts in New Brunswick.

More precisely, her postdoctoral work considers the need to understand how the COVID-19 pandemic has exacerbated and altered existing barriers for women and gender-diverse people who are accessing services and supports related to intimate partner violence and gender-based violence in the province.

**Dr. Petrea Taylor** is an Assistant Professor with the Faculty of Nursing (FON), UNB. Her program of research is gender, violence, and health, with a particular interest in women's mental health, suicidal-ity, and stigma. While working as a clinical nurse specialist in Addictions and Mental Health, Horizon Health Network, Petrea completed (2018) with an Interdisciplinary PhD (Nursing, Sociology, Philosophy). Upon graduating, Petrea accepted a post-doctoral fellowship with supervisor Dr. Kelly Scott-Storey as a post-doctoral fellow funded by CIHR on a Men's Gender Violence and Health Study (MGVHS). In January 2020, Petrea was hired with the FON Accelerated Program at the UNB Moncton site in her hometown.

Dr. Taylor is a Co-Investigator on the project: Variation in Men's Health by Cumulative Lifetime Violence Severity and Social Determinants of Health: A Longitudinal Exploratory Study.

#### New Brunswick Roundtable on Crime and Public Safety

#### **NB Silent Witness Project**

The New Brunswick Silent Witness Project is an exhibit of life-sized red silhouettes representing New Brunswick women who have died tragically at the hands of an intimate partner since 1990. Each life-sized red silhouette represents a woman who once lived, worked, and played amongst us. They were daughters, sisters, mothers, aunts, friends, neighbours and employees. Because these women no longer have a voice, the silhouettes are called the Silent Witnesses. However, by listening to their stories and honouring their lives, they have a strong, clear collective voice that helps all of us to explore ways to create awareness and prevent future domestic deaths.

This year, the NB Silent Witness Project committee supported the completion of two new silhouettes recognizing Mindy Godin of Grand Falls NB, and Sherry Rediker-Tompkins of Miramichi NB.

#### **University Women's Centre**

The University Women's Centre (UWC) is a safe space on the UNB campus that serves the tri-campus student community (UNB, STU, NBCC).

Its physical space at the Student Union Building is available for students to study, hang out, and breastfeed in a comfortable, non-judgemental environment. The Center offers resources on safe sex, sexual health, safe injections, and provides free condoms, dental dams, and feminine hygiene products. The UWC is also focused on promoting gender equality and women's rights by hosting a variety of events during the school year.

This year, the MMFC collaborated with the UWC and the UNB Student union to host a documentary film screening of A Better Man, featuring a guided conversation by Tod Augusta-Scott on repairing harm in relationships. # Education

#### Family Violence Issues Certificate

The MMFC continues to offer the Family Violence Issues Certificate in partnership with the Faculty of Arts, allowing students the opportunity to obtain an interdisciplinary micro-credential.

The Family Violence Issues Certificate accepted 9 new students and saw another 4 completing the program during the previous academic year.

Students who enroll in the FVI Certificate program must complete eight (3ch) courses related to the study of family Violence, selecting courses from three of the following categories:

• Core courses: All the material in these courses relates to the study of family violence. Students must take a minimum of three core courses, many of which are available online.

• Intensive courses: 60% of the material in these courses relates to family violence. Students can take a maximum of three intensive courses. An Arts Internship (Arts 3000) with an agency or government department related to the family violence field is included in the list of intensive courses.

• Supplementary courses: At least 30% of the course material relates to family violence. Students take a maximum of 3 supplementary courses from a list of almost 50 courses.

#### **Essential Skills for Interviewing Children**

This self-paced course is the culmination of over 12 years research and development by the Centre for Investigative Interviewing (CII). The CII is a global leader in the field of interviewing children. The training is relevant for professionals working with vulnerable persons in the sectors of domestic violence, sexual violence, child protection, criminal justice, education, healthcare, and more.

The course takes 35-45 hours and focuses on the 'how to' of interviewing children for professional investigation purposes (e.g., abuse investigation, non-criminal wrongdoing, medical decisions). It is practical and interactive in nature, including a child avatar, films, quizzes, webinars, and one-on-one sessions (over the phone or web) with a trainer. A certificate is provided on completion.

The course focuses on the questioning strategies needed to: build rapport, encourage disclosures, keep the child talking (and steer them towards providing important details while minimizing error), and make the interview as stress-free as possible. The following modules are included:

Module 1: Establishing 'best practice' in interviewing children

- Module 2: Defining the various questions
- Module 3: Understanding memory and language development

Module 4: Choosing the most effective open-ended questions

Module 5: Putting the right questions into practice

Module 6: Introducing the topic of concern

Module 7: Introducing an interview protocol




