About this Codebook

This reference guide is intended for users of the Horizon Inpatient Data. This guide covers hospital's inpatient admissions across New Brunswick's health zones 1, 2, 3, and 7, providing patient demographics, geographic patterns, and hospital details. It includes key variables such as age, sex, admission and discharge dates, and standardized procedure codes, enabling analysis of hospital efficiency, patient outcomes, and cost-effectiveness. This dataset supports healthcare providers, policymakers, and researchers in improving services to patients across the region.

Overview

The Horizon Inpatient Data provides a comprehensive overview of inpatient admission activities across health zones 1, 2, 3, and 7 in New Brunswick. The dataset spans multiple fiscal years and includes detailed information on various hospitals within these zones. Key variables include patient demographics such as age and sex, which are crucial for understanding the population served and identifying trends. The dataset also records the residence code of patients, offering insights into geographic patterns and potential disparities in access to services in regions.

In addition to demographic information, the dataset captures critical clinical and administrative details. Admission and discharge dates, along with the length of stay, help in analyzing hospital efficiency and patient flow. The discharge disposition variable indicates the patient's status, which is essential for assessing outcomes and planning follow-up care. The main patient service code and various classification systems, such as Case Mic Grouping (CMG+) provide a standardized way to categorize acute care inpatients into groups by similar diagnosis and/or interventions, length of stay (LOS) and resource use. The Expected Length of Stay (ELOS) is included to represent the length of time a patient is expected to stay in a facility as determined by the CMG assignment and the 5 factors.

ResidenceCode & ResidenceCodeText

Represents the patient's residence area either in New Brunswick or outside the province. Some extra characters in the spellings of the text will need to be considered, e.g., “Lac Baker Village” and “Lac-Baker Village” seem identical but are reported separately, however they have the same Residence Code of 1337.

AdmitDate

The date of patient admission with the format of MM/DD/YYYY.

AdmitTime

The time of patient admission with a format of HH:MM. Please note that the AdmitTime is a 24-hour time, e.g., 8 PM is reported 20:00, and 8 AM is reported 08:00.

DischDate

Discharge Date, MM/DD/YYYY.

DischargeTime

Discharge Time, is a 24-hour time HH: MM.

LOSDays

Length of Stay in the hospital in days.

LOSHours

Length of stay in the hospital in hours.

AcuteDays

Acute days in hospital.

ALCDays

When the Length of Stay and the Acute Days are not equal, the ALCDays shows the difference. For example, if LOSDays=25 and AcuteDays=13, then ALCDays=12.

Categorizes if the surgery was make as an emergency of not.

InstitutionFrom

The institute that the patient comes from. The value of the variable consists of a leading numeric code followed by a location name. Only using the leading code is not recommended as it has been changed over time. That being said, based on the admit date, you may find two different leading codes for the same location. For example, the Chalmers hospital has the leading codes 001 and 30001.

InstFromType

Institution type that the patient comes from. If not missing, it is recommended to delete the leading digits because there are cases with the same leading code and different institute type.

DischrgDisposition

The variable shows the discharge disposition type that ranges from discharge to private home, with and without support service, to transfer to an acute care inpatient institution. Here is a list of some two-digit leading characters that are mostly used.

Case Mix Grouping (CMG) & CMG Text

The numbered cell/group to which an acute care inpatient is assigned. It is a CIHI grouping methodology that categorizes acute care inpatients into groups by similar diagnoses and/or interventions, length of stay, and resource use.

Estimated length of Stay (ELOS)

The Expected Length of Stay (in days) is a value that represents the length of time a patient is expected to stay in a facility as determined by the CMG assignment and the 5 factors.

Age Category

The CMG Age Category is the alphabetic age group code that represents the age group and category to which the case is assigned for RIW calculation.

Case Weight

Intervention Event Count

Multiple interventions may be performed during a single Intervention Event (IE). By definition, cases in the intervention partition will have an IE count of at least 1. The IE codes are defined as follows:

It should be emphasized that only intervention events 2 and 3 are considered factor cases and receive ELOS and RIW adjustment.
