2024-25 Performance Objectives

The Research Support Fund (RSF) assists Canadian postsecondary institutions such as the University of New Brunswick (UNB) with the indirect costs associated with managing the research funded by the Tri-agency. The Incremental Projects Grant (IPG) and Research Security (RS) grant are streams of RSF. IPG provides further support for the indirect costs of research with a focus on four priority areas that cut across the five categories of RSF eligible expenses. The four priority areas include: innovation and commercialization, facilities renewal, information resources, and equity, diversity and inclusion. RS is categorized as a fifth priority area of the IPG. The RS grant supports activities related to the indirect costs of research security and to the National Security Guidelines for Research Partnerships.

The majority of the funds from the RSF grant continue to support on-going indirect costs such as library acquisitions, IT services, and research support. The IPG funding is continuing to be applied to develop support and resources for researchers working with Indigenous peoples and communities. Similarly, the RS funding is continuing to be applied to develop support and resources for safeguarding research.

The following performance objectives are proposed for 2024-25, with the goal of continued investment into supporting UNB's research community.
