2020-21 Performance Objectives Outcomes Report

The Research Support Fund (RSF) Program assists UNB with the indirect costs associated with managing the research funded by the Tri-agency. The Incremental Projects Grants (IPG) funding is a stream of the RSF program that provides further support for the indirect costs of research. In 2020-21, the RSF and IPG funds allowed UNB to continue to grow its research competitiveness by investing in its research capacity and research support. The following are examples of RSF investments; they do not cover all expenditures supported by the RSF program. The IPG funding was invested into one project, research policy development.

The RSF investments were influenced by the pandemic as the university was closed and/or had restricted access for a large portion of 2020-21. Faculty and staff were working remotely, requiring more on-line tools and capabilities. Investments that would have been directed at research facilities, such as utilities, were redirected to research resources, such as online tools.

Associated outcomes were lower than projected as the pandemic had an impact on research activities. A number of factors affected the target outcomes, such as but not limited to, the university being closed and/or having restricted access as mentioned above; field work significantly delayed and/or cancelled, and many agencies, such as Tri-Agency providing extensions to existing grants with funding. Even with new funding programs associated with the pandemic, the university submitted fewer applications and received fewer awards. However, research revenues for 2020-21 increased to \$55 million (projected, not confirmed) from a little over \$50 million in 2019-20.
